

# FG Approves Bakassi Deep Seaport, \$2.27 bn. **I**





The Federal **Executive Council** (FEC) has approved three major transformative Public-Private Partnership (PPP) projects, unlocking over №6.43 trillion (approximately \$4.29 billion) in private capital investment for the Nigerian economy.


Among the

flagship approvals is the Bakassi Deep Seaport, a strategic maritime infrastructure project expected to attract about \$2.27 billion in private investment.

Speaking on the approval, the Director-General of the Infrastructure Concession Regulatory Commission (ICRC), Dr. Jobson

Osedion Ewalefoh, described the project as a game-changer for Nigeria's maritime and logistics ecosystem.

"The Bakassi Deep Seaport will serve as a new maritime gateway for Nigeria's North-Central and North-East regions, while also functioning as a major logistics



hub for West and Central Africa.

It is a greenfield development designed to accommodate large vessels and integrated with an industrial cluster and a Free Trade Zone. The project will create thousands of jobs and position Nigeria as a preferred maritime destination," he

stated.

The approval of the Bakassi Deep Seaport under the PPP framework underscores the Federal Government's commitment to infrastructure-led economic growth, regional trade expansion, and private-sectordriven development.

It is also

noteworthy that during his campaign tour of Cross River State, Mr. President promised to revisit the Calabar Deep Seaport project—a commitment now taking concrete shape through this strategic.

### DESTRUCTION/STEALING OF PUBLIC UTILITIES BY CRIMINAL AND UNSCRUPULOUS ELEMENTS

The Government of Cross River State has observed with dismay and total disappointment the inordinate stealing and destruction of Public Utilities recently installed by the "People First" administration of His Excellency, Senator Prince Bassey Edet Otu for use by members of the Public, especially in this Yuletide Season of Sweetness.

These unscrupulous and criminal elements are surrespitiously destroying and vandalizing Solar Light Installations, Christmas Lights installed to light up the Calabar City Centre in the Spirit of Yuletide Season while some have taken their destructive tendencies too far by stealing Port-Harcourt Electricity Distribution Company's Meters, thereby obstructing Power Supply in some parts of the Calabar Metropolis. The Government in very strong terms, condemns these unwholesome trends which it should be noted, are alien to the Culture and tradition of our people. Besides, these destructive activities totally negate the robust infrastructural development of the State in line with the "People First" Agenda of Governor Otu, who is putting in place all these social amenities and facilities for use by the populace.

Accordingly, the Government has raised the RED FLAG and hereby directs all Security apparatus in the State to beam their search light on these criminal elements and miscreants with a view to arresting them to face the full weight of the Law. Government further directs the Special Adviser on Public Utilities and his team that have the mandate to protect, secure and provide services to collaborate with all relevant Government MDAs to embark on massive sensitisation of residents on safety, compliance and prosecution of defaulters.

Members of the Public are kindly advised to take note and report any suspicious activity and movement around these installations and amenities to: Engr. Jerome Egbe, Ph.D Special Adviser to the Governor on Public Utilities or to the nearest Police Station for prompt and necessary action.

### Gov Otu Unveils Elders Advisory Council to Strengthen Governance in Cross River



overnor **Bassey Edet** Otu on Thursday inaugurated the Elders Advisory Council of the **Cross River State** Consultative Forum (CRSCF), a strategic body created to offer guidance and strengthen feedback channels for the state's governance.

Represented by his Deputy, Dr. Peter Odey, the Governor reaffirmed the administration's commitment to participatory leadership, stressing that the establishment of the council reflects the government's belief in the wisdom and experience of senior citizens.

"Governments that have this quality of advisors cannot fail, and will not fail," Dr. Odey said. He described the Otu-led administration as "people-centred, an administration that believes in the people of Cross River State."

The Deputy Governor also revealed that



Governor Otu was unavoidably absent due to his firm commitment to the state's ongoing asset recovery efforts. "The Governor is out to reclaim all assets of Cross River State," he stated, adding emphatically: "Let it be on record that our oil wells will be restored."

Earlier, the Chairman of the Consultative Forum, Barr. Eyo Nsa Ekpo, explained that the Elders **Advisory Council** was created to sustain elite consensus across the state and galvanize support for the Governor's second-term bid. He further described the council as "a filter and feedback

mechanism to monitor how government policies and projects impact the ordinary citizen."

Barr. Ekpo also highlighted key achievements of the current administration, including the completion of over 200 kilometres of roads, employment



of more than 8,000 citizens, and the recovery of Tinapa from the Asset Management Corporation of Nigeria (AMCON).

In his inaugural address, former Governor Chief Clement Ebri, who serves as Chairman of the Elders Advisory Council, pledged total commitment to the task ahead. He expressed delight that the government values constructive advice, noting that the Deputy Governor's assurances reflect genuine openness.



Justice and Attorney General of the State Mr. Ededem Ani Esq. declared the programme open with an inspiring welcome address. He emphasised the Ministry's commitment to continuous professional development, modernisation of legal practice, and the adoption of international best standards in justice delivery. He noted that the


legal landscape is evolving rapidly, especially with the integration of technology and emerging global legal trends, and charged participants to take full advantage of the sessions.

The Solicitor-General and Permanent Secretary, Mr. Anthony Effiom Esq. led the introduction session, outlining the objectives of the training and highlighting the Ministry's drive for

structured learning, mentorship, and progressive reforms in public law practice.

The programme featured renowned legal practitioners Mr. Saheed Adebisi, Victor Opera, Mr. Tola Oshobi SAN, and others. Tobenna Erojikwe the Chief Facilitator, widely respected for his expertise in legal education and law office management, delivered highimpact lectures and





practical exercises tailored to the needs of public law officers.

The sessions combined lectures, interactive workshops, and practical simulations to ensure improved knowledge retention and realworld application.

### Cross River, Presco Sign MoU to Revitalize Boki, Nsadop Oil Palm Estates

have signed a
Memorandum of
Understanding
(MoU) to formalise
a strategic
partnership aimed

at revitalising the Boki and Nsadop Oil Palm Estates and repositioning the state as a major player in Nigeria's oil palm value chain.

The MoU signing ceremony, which

held at the Cross River State Privatization Council office in Calabar, weekend, marked a significant milestone in the state's agricultural and economic





reform agenda under the leadership of Governor Bassey Otu.

Speaking at the

ceremony, the Chairman of the State Privatization Council, Chief Bassey Okon, recalled the historic roots of oil palm development in the former Eastern Region under the visionary leadership of Dr. Michael Okpara, assisted by renowned businessman Sir Odumegwu Ojukwu. He noted that Cross River State inherited a large number of oil palm estates following state creation in 1967 due to its vast landmass and forest resources.



He explained that successive administrations had pursued reforms to rescue the estates from decades of neglect, beginning with the privatization framework introduced during the administration of former Governor Donald Duke and sustained under Governor Liyel

Imoke. According to him, the current administration of Senator Bassey Otu is consolidating on those reforms by opening up the Boki and Nsadop estates to private-sector efficiency, guided by the principle of maximum social gains.

The council chairman said Presco PLC was

selected based on its proven track record across Edo, **Delta and Rivers** States, stressing that the company's investment would unlock massive employment opportunities, stimulate rural development and generate revenues through taxes, produce fees and ancillary economic activities. He added



that the project is expected to create thousands of direct and indirect jobs, reduce rural—urban migration and enhance security in host communities.

In his remarks, the Managing Director and Chief Executive Officer of Presco PLC, Mr. Reji George, described the MoU signing as a milestone for both the company and Cross River State. He thanked Governor Bassey Otu, the Privatization Council and other stakeholders for the trust reposed in Presco.

Mr. George said Cross River's

favourable soil quality, rainfall and long history of oil palm cultivation align with Presco's long-term strategy of expanding sustainable palm oil production to meet domestic demand. He assured that Presco would immediately commence environmental and social impact assessments, nursery development and plantation establishment, in line with global best practices.

He further reaffirmed the company's commitment to sustainable agriculture,

environmental protection and strong community partnerships, noting that Presco's operations would deliver shared value to host communities, employees, government and investors.

The event was witnessed by notable government officials including the Commissioner for Commerce, Dr. (Mrs.) Abigail Orok, Chairman of the State Civil Service Commission, Sir Maurice Effiwatt, and representatives of the Ministry of Justice.






"Misinformation is dangerous. We must avoid actions that may disrupt the peace we cherish. As a people, we must stay united and avoid spreading


importance of continuous service, humility, and dedication to the Efik people and the wider Cross River community, and offered blessings for Chief Okor's continued leadership.

## Gov. Otu Declares FG-World Bank 2-Day Blue Economy Upskilling Programme Open in Cross River



n a bid to strengthen the State's position in Nigeria's emerging maritime and blue economy landscape, the Cross River State Governor, Sen. Prince Bassey Edet Otu, on Thursday declared open a 2day Upskilling

Programme for stakeholders in the sector at the State Library Complex, Calabar.

In his keynote address, Governor Otu, represented by his deputy Rt. Hon. Peter Odey, described the event as a timely

intervention to build capacity and unlock economic opportunities in the state. He recalled that the Federal Ministry of Marine and Blue Economy was established in August 2023 and that Nigeria was re-admitted into Category C of the





International
Maritime
Organization (IMO)
Council in 2025,
after a 14-year
absence- a feat he
attributed to the
vision and
commitment of
President Bola
Ahmed Tinubu
toward economic
diversification.

Citing NBS data, Rt. Hon. Odey noted that Nigeria's maritime sector contributed N113.59 trillion to the national GDP in Q3 2025, and referenced NIMASA's valuation of the country's untapped blue economy resources at about \$296 billion, calling the sector "the giant of the non-oil economy." He added that inspired by the President's efforts, his administration created the Cross River State Blue

Economy Agency in 2024 to harness the state's marine ecosystem, open new revenue streams, and align with the Federal Government's sustainable blue economy strategy.

He highlighted ongoing interventions in the state's maritime sector, including progress on the Bakassi Deep









Seaport, the distribution of over 100 motorized fishing boats in

2024, renovation of the Marina Resort, planned upgrade of the Calas Vegas Resort, and revitalization of the KADA Cinema waterfront. Odey

emphasized that upgrading skills is vital in an era driven by rapid advances in science, technology, and AI, describing the programme as a valuable platform for stakeholders to gain relevant

knowledge and build the capacity needed to compete globally.

"This programme goes beyond a mere talk-shop," he said. "Our target is to produce a skilled maritime workforce capable of taking up global

opportunities."

He announced that the training-being the first of its kind under his administration-will become a routine feature in the state's human capital development agenda in line with the "People First" mantra, and encouraged all participants to put the knowledge they acquire into practice and contribute meaningfully to the growth of the state's blue economy.

Delivering the welcome address, Special Adviser to the Governor on Blue Economy, Barr. Melodie Lebo, described the initiative as the start of a new era where the state's rivers, coastline, and aquatic







The DG who was speaking in an interview with correspondents in his office emphasized that the State Government has activated all law enforcement apparatus including the traditional governing structure to keenly watch out for culprits for arrest and prosecution.

Mr Gill lamented the progressive destruction of the State flora and fauna in massive scale through indiscriminate bush burning especially during the dry season.

He disclosed that 2025 recorded large farm lands



and reserve forests as well as crops worth millions of Naira consumed by unwarranted inferno occasioned

by careless use of fire which has grossly affected the socio-economic landscape of the State.

According to him, while he acknowledged that rural farmers require discreet burning of farmlands for crop cultivation igniting portions not needed is uncalled for culminating in economic waste.

He challenged the leadership at the grassroots level to support government in the campaign against indiscriminate bush burning by monitoring their subjects with a view to checkmating the ugly trend.

The DG also expressed his worries over the high rate of urban fires which has in recent times consumed property worth billions of Naira leaving in it



trails lost of lives and massive displacement of people.

He attributed the causes of the incidences to electrical defaults, cooking gas explosions and improper handling of other combustible materials stressing that such sad situations can be controlled with

commitment by citizens.

Mr Gill said that in due course the consistent synergy with fire fighting outfits in the State will converge in intensive public training on the prevention and Management of accidental infernos.

The DG used the opportunity to commend the State

Governor Apostle Senator Prince Bassey Edet Otu for his dogged efforts towards revamping the Fire Service architecture across the State.

RESOLUTIONS OF THE 15TH MEETING OF THE CROSS RIVER STATE EXECUTIVE COUNCIL HELD ON WEDNESDAY, 10TH DECEMBER, 2025 AT THE STATE EXECUTIVE COUNCIL CHAMBERS, CALABAR, CROSS RIVER STATE

#### INTRODUCTION:

# President Tinubu: No Going Back On The Directive To Withdraw Police Officers From VIPs



resident Bola Tinubu on Wednesday in Abuja said the directive to redeploy police officers working with VIPs, VVIPs and ministers was not negotiable, admonishing all ministers to ensure immediate compliance.

Speaking at the opening of the Federal Executive Council (FEC) meeting in the State House Council Chamber, the President warned against non-compliance.

"If you have any problem because of the nature of your assignments, please contact the IGP and get my clearance," he said.

President Tinubu directed the

The President noted that police officers were trained to protect the lives and property of citizens, particularly the most vulnerable in society, and the protection of a select group of VIPs and VVIPs was not their responsibility.

President Tinubu said the Minister of Interior, Olubunmi Tunji-Ojo, will make arrangements for the replacement of police officers

"The National Security and Civil Defence Corps are trained for VIP protection, and they are armed too," he added.

The President noted that the police would be mobilised appropriately to tackle the country's security challenges.

He said the entire structure will be reviewed to better address vulnerable citizens and communities.

"We face challenges here and there of Kidnapping, banditry and terrorism. We need all forces utilised. I

know some people are exposed; we will make the exceptions. The Civil Defence is very much around," the President stated.

President Tinubu said ministers should meet the Inspector General of Police and get his clearance for special assignments that require police protection.

"NSA take this very seriously," he added.

The President also urged the Vice President Kashim Shettima, who is the Chairman of the National Economic Council (NEC), to further sensitise governors and



other stakeholders on the implementation of the reforms on ranching.

President Tinubu directed the Minister, Idi Muktar Maiha, to commence the mobilisation process, with particular emphasis on areas facing conflict.

"The Minister of Livestock, see which village or grazing area can be rehabilitated for ranching. We must eliminate this area of conflict and make the livestock reform economically viable.

"The opportunity is there, let's utilise it. You should emphasise the constitutional requirement that the land belongs to the state," he added. The President said villages and communities facing conflicts must be salvaged.

The President noted that implementing ranching will reduce conflicts between herders and farmers and attacks on the most vulnerable members of society.



# C'River Assembly Removes Hon. Theresa Ushie as Bekwarra LG Chair, Orders Bye-Election Within 30 Days

he Cross **River State** House of Assembly has removed the Chairman of Bekwarra Local Government Council, Hon. Theresa Ushie, following the adoption of the report of the House Committee on Judiciary and Public Petitions.

Her removal was affirmed after 19 out of 25 lawmakers voted in support during today's plenary.

The issue began on June 10, 2025, when the Assembly received a petition from eight councillors of the Bekwarra Legislative Council. After initial

debate, the House suspended Hon. Ushie for 90 days and mandated the Vice Chairman, Hon. Egbung Odama, to act in her stead while the Committee conducted a full investigation.

Presenting the report, the Committee stated that the petition

dated May 19, 2025, raised serious concerns about how the council was being run. According to the report, the councillors accused the suspended chairman of corruption, misuse of authority, arbitrary stoppage of their salaries, and operating the council without compliance with due process.

"After meeting with the petitioners, the suspended chairman, and various stakeholders in Abuochiche, the Committee found the allegations weighty and clearly established," the Committee Chairman said while presenting the findings. "The conduct of the chairman fell below the

expectations of her office, and the evidence before us supports her removal."

The report further noted that the Committee's visit to Bekwarra provided additional clarity. "Community members and officials gave testimonies that reinforced the concerns raised in the petition," the Chairman added.

Adopting the recommendations, the House resolved that Hon. Theresa Ushie be removed from office for gross misconduct.

The Assembly also directed the Cross River State Independent Electoral Commission (CROSIEC) to conduct a bye-election within 30

days to fill the vacant position.

In his closing remarks, the Speaker of the House, Rt. Hon. **Elvert Ayambem** emphasized the Assembly's commitment to accountability: "This House will always defend transparency and uphold the law. Our duty is to the people of Cross River State."

# ILLEGAL OPERATIONS OF LOTTERY AND GAMING BUSINESSES IN CROSS RIVER STATE

The attention of the Government of Cross River State has been drawn to the illegal and deceptive operations of some Lotteries and Gaming Companies and Organisations in Cross River State without proper registration and authorisation from the Cross River State Lotteries and Gaming Agency established by Law No 3. of 2024.

These illicit operations being perpetrated by some Lotteries and Gaming businesses, both those with physical office addresses and those operating online, are a flagrant violations of the Supreme Court Judgement of 22nd November, 2024 which nullified the National Lotteries Act 145 Laws of the Federation of Nigeria 2005 and vested the regulatory powers over Lotteries and Gaming businesses on States of the Federation of Nigeria.

The Government of Cross River State wishes to restate categorically here that by the Cross River State Lotteries and Gaming Law assented to by His Excellency, Governor Bassey Edet Otu on the 12th of May, 2025, only the Cross River State Lotteries and Gaming Agency is vested with powers to issue Licences and regulate Lotteries and Gaming businesses and Services in any part of the State, be it a physical office or online.

For the avoidance of any doubt, these Lotteries and Gaming activities include Online Sports Betting, Casino Games, Public Online Lotteries, Pools Betting, Raffle Draws, Scratch Cards, Interactive Games and any other game of chance where a stake and potential winning is involved.

Government hereby enjoins all Radio and Television Stations operating in the State to please liaise effectively with the Advertising Regulatory Council of Nigeria (ARCON), the Cross River State Signage and Advertising Agency (CRISSAA) to demand for the Agency's Operational Permit before accepting to publicize their businesses on air as paid advertisements.

Finally, the Government sincerely appreciates and thanks all Lotteries and Gaming Companies and Organisations that have complied with the Law and solicits the understanding and cooperation of all concerned while also making it clear that violators/defaulters shall face the full wrath of the law.
