Otu affirmed that the Calabar Carnival remains one of the most important in the tourism calendar of the state as it translates two decades of ingenuity, resilience, continuity and sustainability.

Admonishing the competing and non competing brands to refine their skills and present the best in their presentation, he said: "I see a number of wants-to-be bands, your performance today will show whether you will be promoted to that vacancy, so put in a quintessential performance today and we will put you there.

The governor used the event to

recognise and applaud his predecessors including former Governors' Donald Duke for the vision of the Carnival, the sustainability by Liyel Imoke and the resilient nature of Ben Ayade, who in spite of COVID 19, still saw the event through.

Earlier, Chairman Cross River Carnival Commission, Gabe Onah, remarked that the event has tremendously transformed the commercial economy of the state.

Onah announced the presence of French and English speaking ECOWAS Commission, Spanish consul, Portuguese



Ambassador as well as other relevant local and international partners to the year's event.

For the Portuguese Envoy, Paulo Santos, he lauded the Cross River government for the success of the Carnival which is in its second decade.

Santos, overwhelmed by the organisation of the event, remarked that he would encourage other diplomats in Abuja and its environs to seek end of year holidays in Calabar.

Revellers after the flag off danced through the 12 kilometres Carnival routes, stopping at

the various adjudication points to interpret the theme in line with the guidelines of the competition.

Calabar Carnival**Gov Otu flags off 2025 Bikers Carnival**

Cross River State Governor, Senator Bassey Edet Otu, has reaffirmed his administration's commitment to safety, tourism promotion and global cultural exchange, as he flagged-off the 2025 Bikers Carnival in Calabar, one of the signature

events of the Carnival Calabar festival.

Represented at the event by his Deputy, Rt. Hon. Peter Odey, who declared the Bikers Carnival open amid cheers from bikers, residents and visitors drawn from within and outside the state, the Governor assured

participants and the international community that Cross River State remains safe and well-prepared to host large-scale events. He disclosed that he personally inspected the carnival routes to ensure they were motorable and free of hazards.

“Let us tell the



world that Cross River State is safe. I have gone round the routes myself; there are no potholes and the roads are smooth," he said.

The Governor stressed the importance of strict adherence to safety protocols, urging all bikers to wear helmets, reflective vests and ensure

proper riding discipline to avoid accidents. He added that ambulances, medical personnel and insurance coverage had been put in place to guarantee a hitch-free event.

"With Doctors on ground, ambulances stationed, and insurance fully covered, we want

this carnival to be remembered only for positive reasons," he stated, before officially declaring the 2025 Bikers Carnival open to the glory of God.

Earlier, Chairman of the Cross River State Carnival Commission, Gabe Onah, described the Bikers Carnival as part of a broader effort to



preserve cultural heritage and reconnect younger generations with the values and creativity embedded in Carnival Calabar.

He also revealed the presence of the ECOWAS Commission, with representatives from 12 member nations, noting that their participation underscored the

growing business, talent and creative-sector opportunities associated with Carnival Calabar on the regional stage.



The event attracted strong international attention, with the Ambassador of Portugal to Nigeria, Paulo Santos, praising the organisation, professionalism and enduring legacy of the carnival. He described his presence in Calabar as both a cultural and historical

“homecoming.”

“Calabar means ‘the quiet harbour’ in my language,” the ambassador explained, recounting the historic ties between Portugal and the ancient city. He lauded the enthusiasm and scale of participation, saying the carnival looked as though it had been organised

for “200 or even 2,000 years,” rather than just two decades.

Ambassador Santos pledged to encourage other diplomats in Abuja to experience Carnival Calabar, urging them to forgo their usual end-of-year holidays to witness what he described as one of Nigeria’s finest



cultural showcases.

One of the emotional highlights of the event came from 86-year-old UK-based diasporan, Mr. Richard Nzerem, originally from Imo State, who expressed deep gratitude for witnessing what he called a once-in-a-lifetime experience.

Having lived in the United Kingdom for over 60 years, Nzerem said the Bikers Carnival exceeded his expectations and left him fulfilled. He thanked the state government for granting him the opportunity to be part of the historic moment.

RE-DESIGNATION OF THE INFORMATION CADRE AS INFORMATION & PUBLIC RELATIONS OFFICER CADRE

The Office of the Head of Service wishes to notify the Ministry of Information of the re-designation of the existing Information Cadre to the Information & Public Relations Officer (IPRO) Cadre with immediate effect.

2. The re-designation is in line with ongoing reforms aimed at strengthening professional communication functions, enhancing public engagement, and ensuring alignment with national and global standards of public information management.

3. Consequently, the following academic qualifications and professional certifications shall now be recognized and accepted for entry, progression, and professional practice within the Information & Public Relations Officer Cadre:

- a. Bachelor's Degree in Mass Communication
- b. Bachelor's Degree in Journalism
- c. Bachelor's Degree in Theatre Arts
- d. Other related degrees and communication-based qualifications
- e. Professional certifications from the Nigerian Institute of Public Relations (NIPR)
- f. Professional certifications from other recognized and reputable bodies in the field of communication, media, and public relations.

4. You are requested to take necessary steps to implement this directive, including updating all establishment records, scheme of service references, and relevant personnel documentation to reflect the new designation.

5. Please bring the contents of this circular to the attention of all officers and departments concerned for strict compliance.

Gov Otu Signs 2026 Budget into Law, Reaffirms Commitment to Inclusive Growth

Governor of Cross River State, Senator Bassey Edet Otu, has formally signed the 2026 Appropriation Bill into law, describing the budget as “a statement of purpose and a solemn commitment to social stability,

inclusion, and shared prosperity.” The signing ceremony took place at the Government House before the Speaker of the House of Assembly and members of the House Committee on Finance and Appropriation.

Speaking at the event, Governor Otu said the budget was carefully designed to respond to the realities facing the state while laying a solid foundation for long-term growth. “This budget is more than a legal appropriation,” he declared. “It is our

blueprint for economic transformation, social protection, and the delivery of tangible dividends of democracy to our people.”

The governor commended the House of Assembly for what he described as “diligence, transparency, and patriotism” throughout the budget process. He noted that the legislature’s engagement with the executive, civil society organisations, and state economic managers reflected global best practices. “The successful implementation of this budget will continue to inspire confidence in governance and reinforce accountability in the

Cross River Assembly Passes 2026 Appropriation Bill

The Cross River State House of Assembly has passed the sum of #961, 624, 047, 275.06 as budget for the 2026 fiscal year.

The House increased the 2026 Budget from #780, 590, 204, 746 .66 earlier proposed by Governor Otu to #961, 624, 047, 275.06.

The budget has #671, 272, 468, 487.13 as Capital Expenditure while Recurrent Expenditure stands at #290, 351, 578, 787.95.

The budget, which provides the legal framework for government spending in the 2026 fiscal year, focuses on Infrastructure, Education, Healthcare, Transportation, and Agriculture and will take effect upon assent by Governor Bassey Otu.

Before passing the Appropriation Bill, the House had deliberated on the report of the House Committee

on Finance and Appropriation presented by the Chairman, Hon Cyril James Omini.

The report, amongst other recommendations, emphasized the need for budgetary releases to be given top priority in 2026 fiscal year to enable MDAs carryout Capital projects to enhance their performance, collaboration between Miners and Mining Communities to ensure revenue generation and peace as well as the revival of Songhai Farms.

The report also indicates that the 2026 budget will be funded through; Government Share of FAAC,

Independent Revenue, Aids and Grants as well as Capital Development Fund.

The Leader of the House, Rt Hon Francis Bassey Asuquo described the budget as a "People's First Budget".

In separate contributions, Members commended the Governor for spreading projects across all the Local Government Areas of the State. They also commended the Finance and Appropriation Committee for being thorough during the budget process.

Following a unanimous vote in favour of the passage, the Speaker, Rt Hon Elvert Ayambem

declared the budget passed.

Ayambem directed the Clerk of the Assembly, Barr Catherine Ubi to prepare a clean copy of the bill to be forwarded to the Governor for his assent.

It would be recalled that the State Governor, Prince Bassey Edet Otu, on October 28, 2025 presented a budget proposal of #780, 590, 204, 746. 66 to the House for the 2026 fiscal year tagged "Budget of Inclusive Growth".

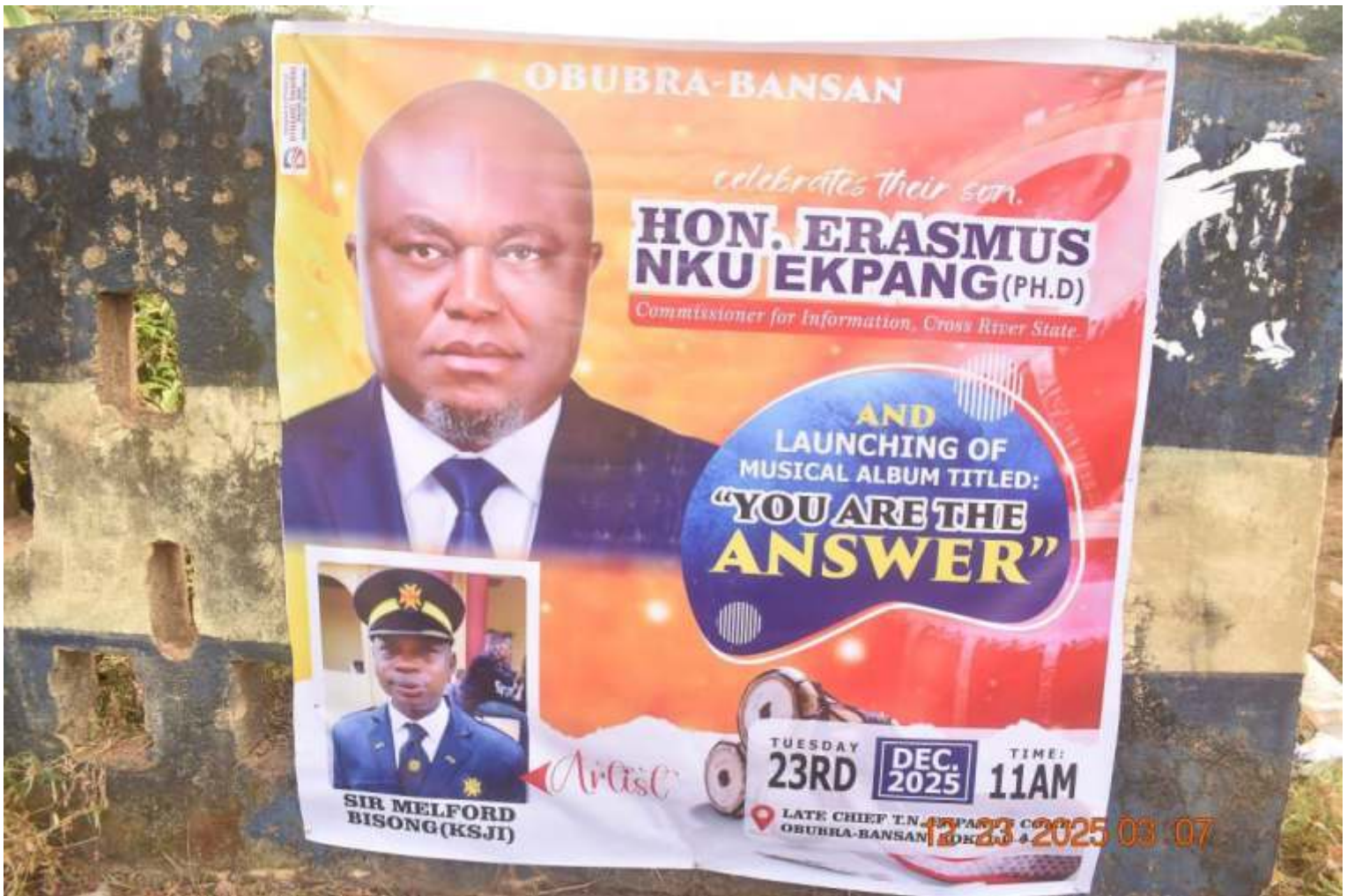

NIN, CAC Numbers To Become Tax IDs From 2026— FIRS



The National Identification Number issued by the National Identity Management Commission (NIMC) has now automatically become a Tax ID for Nigerians starting from January 2026, according to the Federal Inland Revenue Service (FIRS).

The declaration

comes amidst concern over a provision of the tax laws mandating a Tax ID for bank account ownership.

According to data released by the NIMC, a total of 123.9 million Nigerians had been issued the NIN as of October 2025.

In a public awareness campaign on the

new tax laws posted on X on Monday, the Service also noted that for registered businesses, the RC number issued by the Corporate Affairs Commission (CAC) automatically becomes their tax ID under the new tax system.

The Nigeria Tax Administration Act (NTAA) billed to come into force from January 2026, mandates the use of Tax ID for certain transactions, according to the campaign.

It, however, noted that this requirement is not new, adding that it has existed

since the Finance Act 2019 and has been strengthened under the NTAA.

The FIRS added that the new tax ID systems simplify identification, reduce duplication, closes loophole for tax evasion and ensure fairness so that everyone who earns taxable income contributes their share.

"The Tax ID unifies all TINS previously issued by FIRS and states IRS into a single identifier.

"For individuals, your NIN automatically serves as your Tax ID, while for

registered companies, your CAC RC number is used.

"You do not need a physical card; the Tax ID is a unique number linked directly to your identity," the FIRS stated.

While giving an update on the tax laws billed to take effect by January 1, 2026, Chairman of the Presidential Fiscal Policy and Tax Reforms Committee, Taiwo Oyedele, dismissed claims that all bank accounts are mandated to have a Tax Identification Number (TIN) before January 2026.

According to him, Section 4 of the NTAA requires a taxable person to

require and obtain a Tax ID, and a taxable income is anyone who earns income through trade or any economic activity.

He said individuals who do not earn income, such as students and dependents, do not need to obtain a Tax ID.

Oyedele added that anyone operating a bank account for businesses, or a corporate account since 2020, already had a tax Identification number.

Nigerian Navy Rescues 20 Crew Members From Burning Vessel Off Calabar



The Nigerian Navy has rescued 20 crew members from a cargo vessel, MV Chimba Express, which caught fire along the Calabar section of the Oron–Calabar waterways in Cross River State.

The rescue operation was carried out on Monday by

personnel of the Nigerian Navy Ship, NNS OSE, following a distress call from the vessel. Chimba Express was en route from Gabon to Calabar, conveying scrap materials and other logistics, when the fire broke out.

Confirming the incident, the Base Operations Officer of NNS VICTORY, Lieutenant Commander Kelechi

Ahunanya, said the distress call was received at about 1:00 p.m., prompting an immediate response by NNS OSE. On arrival at the scene, naval personnel rescued crew members who had abandoned the vessel as well as those stranded on deck, using life buoys and other emergency equipment.



According to him, 20 crew members, comprising 14 Nigerians and six Cameroonians, were successfully rescued and administered first aid.

However, the vessel's Chief Engineer remains missing after

reportedly jumping into the water for fear of an explosion. Lieutenant Commander Ahunanya said search and rescue operations are ongoing to locate the missing crew member.

The Nigerian Navy reaffirmed its

commitment to ensuring the safety of seafarers and the protection of lives and maritime assets within Nigeria's territorial waters.

CLARIFICATION ON REGULATIONS FOR TAKING OF PHOTOGRAPHS AT THE CROSS RIVER STATE LIBRARY COMPLEX

The attention of the Government of Cross River State has been drawn to the unregulated and uncoordinated taking of photographs and making of Videos by users and visitors to the recently re-opened Cross River State Library Complex.

These unwholesome trends have continued to remain an issue of great concern to the Management of the Cross River State Library and the Government wishes to address them in the overall interest of the Public as follows:

1. The Cross River State Library Complex remains a public institution owned by the Cross River State Government. It has not been sold, leased, or transferred to any individual or private entity.
2. Government wishes to however note that certain sections within the State Library Complex -such as the Café and Multi-Purpose areas; are managed spaces established to promote sustainability, orderliness, and the protection of public assets.
3. The already introduced guidelines regulating photography and videography within designated areas of the Library Complex were introduced solely to preserve a conducive learning and research environment for users. These measures were further intended to reduce overcrowding, limit noise and distractions as well as prevent the misuse or damage of Library facilities.
4. Government wishes to emphasize that as a public Library, maintaining quiet study conditions and safeguarding resources remains a core responsibility of Management of the Library.
5. Again, Government recognises the fact that unrestricted filming and photography can lead to congestion and disruption of services for other Library Users.
6. In the light of the above, all clients-group or Individual, MUST give prior

notification and receive formal approval from the Library Management to guarantee seamless identification and Commercial Photography in the Complex.

7. Government further directs all clients and users to strictly adhere to the guidelines to correct all noticeable inconsistencies, enhance engagements and avoid congestion in the Library. They are also to note that these standardised guidelines are not intended to penalise Library Clients and Visitors but to make the Library more accessible, orderly, serene and beneficial to all members of the public.

Finally, Government sincerely appreciates the support so far and solicits for continued cooperation so that together with the Library Management, improved service delivery and transparency will be achieved in line with international best practices.

DG CRSEMA Remind Cross Riverians Of Extant Laws Against Indiscriminate Bush Burning

The Director General, Cross River State Emergency Management Agency CRSEMA, Mr Antigha Gill has reminded the people of the State of the extant laws against indiscriminate bush burning and its consequences.

The DG who was speaking in an interview with correspondents in his office emphasized that the State Government has activated all law enforcement apparatus including the traditional governing structure to keenly watch out for culprits for arrest and prosecution.

Mr Gill lamented the progressive destruction of the State flora and fauna in massive scale through indiscriminate bush burning especially during the dry season.

He disclosed that 2025 recorded large farm lands



and reserve forests as well as crops worth millions of Naira consumed by unwarranted inferno occasioned

by careless use of fire which has grossly affected the socio-economic landscape of the State.

According to him, while he acknowledged that rural farmers require discreet burning of farmlands for crop cultivation igniting portions not needed is uncalled for culminating in economic waste.

He challenged the leadership at the grassroots level to support government in the campaign against indiscriminate bush burning by monitoring their subjects with a view to checkmating the ugly trend.

The DG also expressed his worries over the high rate of urban fires which has in recent times consumed property worth billions of Naira leaving in it



trails lost of lives and massive displacement of people.

He attributed the causes of the incidences to electrical defaults, cooking gas explosions and improper handling of other combustible materials stressing that such sad situations can be controlled with

commitment by citizens.

Mr Gill said that in due course the consistent synergy with fire fighting outfits in the State will converge in intensive public training on the prevention and Management of accidental infernos.

The DG used the opportunity to commend the State

Governor Apostle Senator Prince Bassey Edet Otu for his dogged efforts towards revamping the Fire Service architecture across the State.

ILLEGAL OPERATIONS OF LOTTERY AND GAMING BUSINESSES IN CROSS RIVER STATE

The attention of the Government of Cross River State has been drawn to the illegal and deceptive operations of some Lotteries and Gaming Companies and Organisations in Cross River State without proper registration and authorisation from the Cross River State Lotteries and Gaming Agency established by Law No 3. of 2024.

These illicit operations being perpetrated by some Lotteries and Gaming businesses, both those with physical office addresses and those operating online, are a flagrant violations of the Supreme Court Judgement of 22nd November, 2024 which nullified the National Lotteries Act 145 Laws of the Federation of Nigeria 2005 and vested the regulatory powers over Lotteries and Gaming businesses on States of the Federation of Nigeria.

The Government of Cross River State wishes to restate categorically here that by the Cross River State Lotteries and Gaming Law assented to by His Excellency, Governor Bassey Edet Otu on the 12th of May, 2025, only the Cross River State Lotteries and Gaming Agency is vested with powers to issue Licences and regulate Lotteries and Gaming businesses and Services in any part of the State, be it a physical office or online.

For the avoidance of any doubt, these Lotteries and Gaming activities include Online Sports Betting, Casino Games, Public Online Lotteries, Pools Betting, Raffle Draws, Scratch Cards, Interactive Games and any other game of chance where a stake and potential winning is involved.

Government hereby enjoins all Radio and Television Stations operating in the State to please liaise effectively with the Advertising Regulatory Council of Nigeria (ARCON), the Cross River State Signage and Advertising Agency (CRISSAA) to demand for the Agency's Operational Permit before accepting to publicize their businesses on air as paid advertisements.

Finally, the Government sincerely appreciates and thanks all Lotteries and Gaming Companies and Organisations that have complied with the Law and solicits the understanding and cooperation of all concerned while also making it clear that violators/defaulters shall face the full wrath of the law.

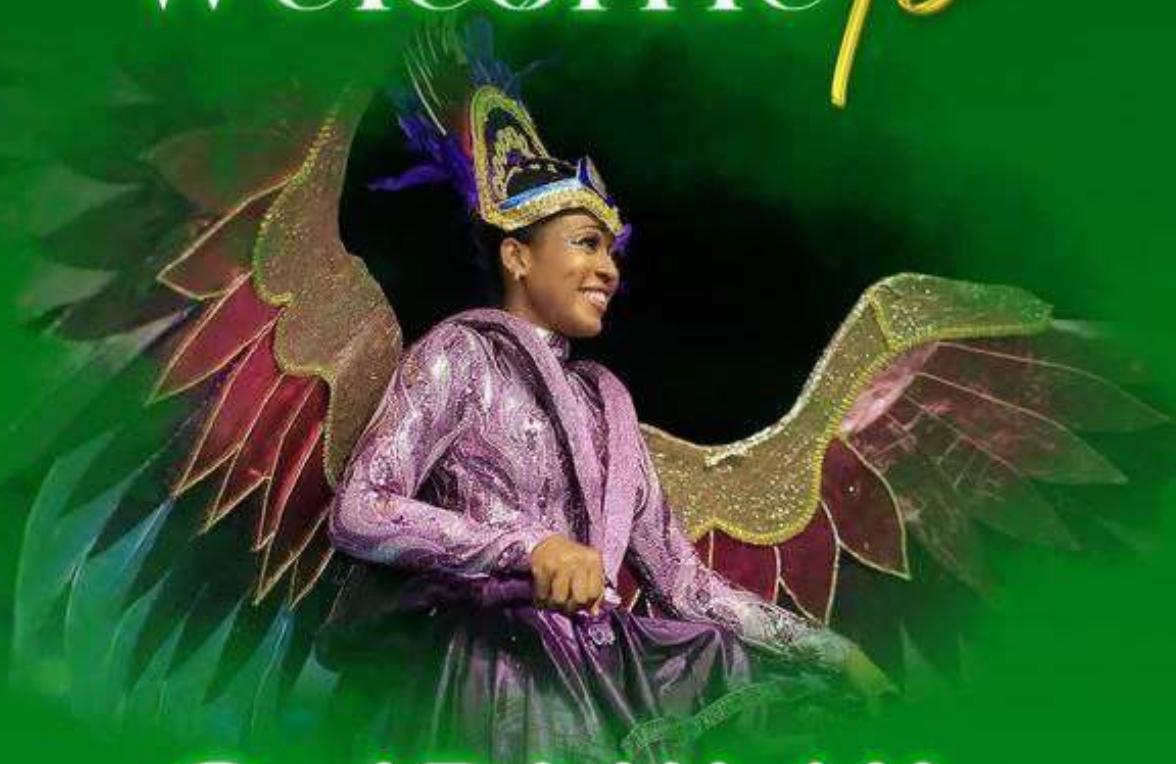

STEPS TO OBTAIN CERTIFICATE OF OCCUPANCY IN CROSS RIVER STATE

- 1** Obtain an Application Form at CRGIA's Office, Old Secretariat Road, Off Murtala Mohammed Highway, Calabar, Cross River State
- 2** Submit Application Form with Required Documents
Fill and submit the form along with necessary documents, e.g. Registered Title Document, survey plan, identification, etc.
- 3** Assessment and Payment of Fees.
The office will assess applicable charges, registration fees, processing fees, etc. Make the required payment.
- 4** Inspection and Publication (for private land)
Property is inspected by LUAC officials
Notice of application is published for 21 days to allow for objections.
After clearance, Governor's Approval in Principle is obtained.
- 5** C of O (Certificate of Occupancy) Engrossment and Signing
The Certificate of Occupancy is prepared (engrossed) and signed by the Governor or delegated authority.
- 6** Registration and Delivery
Final registration is completed at the Lands Registry.
Registered documents are delivered to the applicant (client).
