# Governor Bassey Otu Fulfils Promise: Rewards WAFCON Star Miracle Usani with N50 Million In Calabar



**I**n a grand display of commitment to youth empowerment and sports excellence, the Executive Governor of Cross River State, Senator Bassey Otu, has fulfilled his pledge to Super Falcons defender Miracle

Usani.

The Governor presented the football star with a cash reward of ₦50 million and a plot of land in Calabar, following her pivotal role in Nigeria's victory at the 2025 Africa Women's Cup of Nations (WAFCON).

The celebratory event, held at the prestigious Huggies Royal Hall in Calabar, brought together sports enthusiasts, government officials, and well-wishers to honor the 18-year-old Yakurr-born sensation.





Governor Otu, who was represented at the event by his Special Assistant on Sports, Hon. Chief Ekanem Ekpenyong, emphasized that the reward was not just a gift but a "debt of honor" fulfilled. The Governor noted that the administration remains steadfast

in its "People First" mandate, ensuring that excellence by Cross Riverians on the global stage is recognized and rewarded.

Representing the Wife of the Governor, Rev. (Mrs.) Eyoanwan Bassey Otu, was the Commissioner for Sports Development, Hon. Agnes Atsu. In her

remarks, she lauded Usani as a "shining beacon of hope" for young girls across the state, proving that with determination, the "girl child" can conquer the world. She also thanked the Governor for being a father who always supports his children and keeps to his words.

Beyond the ₦50 million and the land gift, the Governor also

announced several high-level honors for the young defender:  
 • VVIP Status: Usani has been conferred with the

state's highest protocol status for private citizens, granting her access to all official state functions.

Ambassador: She was officially named a Sports Ambassador of Cross River State, tasked with inspiring the next generation of athletes.

- "Miracle on the Pitch": The Governor affectionately dubbed her the "Miracle on the Pitch," recognizing her grit and tenacity during the continental tournament in Morocco.

In a thank you remark, Miss Miracle recounted her journey towards becoming a footballer and the obstacles she faced.

"My Journey Wasn't Easy, "Growing up in Ugep, people told me that football was for boys and

that I would become too masculine. There was no female team, so I played with the boys. Today, I stand here as a champion, and I am proud to represent Cross River and Nigeria," she said.

A visibly emotional Miracle Usani, accompanied by her parents, expressed her profound gratitude to Governor Otu for keeping his word and giving hope to athletes from the state, she promises to continue being a good ambassador of the state and keep the State flag flying high.

The ceremony served as a platform for the state government to reiterate its commitment to rebuilding sports

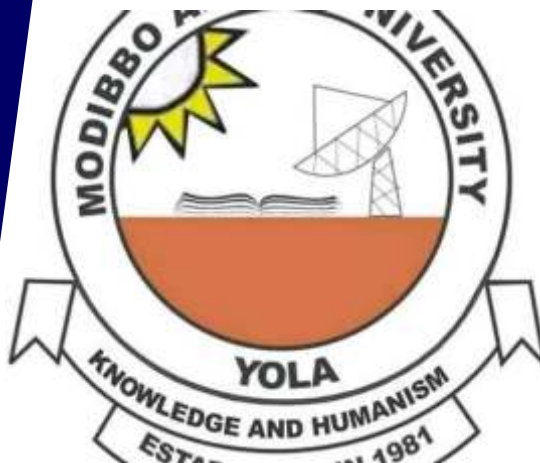
infrastructure.

# Gov Otu Bags Honorary Doctorate from Modibbo Adama University



**I**n recognition of what it described as his far-reaching contributions to governance, public service and humanitarian development across Nigeria, Modibbo Adama University (MAU), Yola, has announced the conferment of Honorary Doctorate on Cross River State governor, Senator Bassey Edet Otu.

The announcement which was contained in an official letter dated January 20, 2026, and signed by the Vice-Chancellor of the University, Prof. Ibrahim Umar stated that the decision followed the approval of both the University Senate and Governing Council, underscoring the institution's collective endorsement of Governor Otu's

leadership credentials and service record.

According to Prof. Umar, "the honour reflects the University's tradition of celebrating leaders whose careers embody service, integrity and societal impact," noting that Governor Otu's public life has been marked by people-centred policies and

a humane approach to governance, which, he said, "have earned him respect within and beyond the borders of Cross River State."

The Vice-Chancellor further explained that Governor Otu will receive the Doctor of Humanities (Honoris Causa), a distinction reserved for individuals whose influence transcends professional boundaries to positively shape social development and national cohesion. "The award is in recognition of your outstanding contributions and humanitarian services," the University stated in its official announcement.

Beyond the

symbolic value of the honour, the University described the conferment as an affirmation of Governor Otu's role as a bridge-builder in public life, whose governance philosophy prioritises inclusion, institutional strengthening and sustainable development. Prof. Umar observed that such qualities align with the core values Modibbo Adama University seeks to promote through its academic and civic engagements.

The formal investiture will take place during the 29th and 30th combined convocation ceremony of Modibbo Adama University, scheduled for Saturday, January 31, 2026. The ceremony will be held at the

University's Convocation Square in Yola, Adamawa State.

While extending the University's congratulations, Prof. Umar, on behalf of the Governing Council, Senate and staff, expressed appreciation for Governor Otu's contributions to national development and public service. He added that the institution "looks forward to the opportunity to formally recognise your achievements," while conveying assurances of the University's highest regards as it anticipates the Governor's presence at the landmark convocation ceremony.



# No State Can Be Economically Viable Without an Enabling Environment for the Private Sector - Dep. Gov Odey



**T**he Deputy Governor of Cross River State, Rt. Hon. Dr. Peter Odey, has emphasized that no state can attain sustainable economic growth without

deliberately creating an enabling environment for private sector participation.

Odey made this statement on Wednesday while receiving the

National President of the National Association of Chambers of Commerce, Industry, Mines and Agriculture (NACCIMA), Engr. Jani Ibrahim, OON, during a courtesy



visit to Government House, Calabar.

According to the Deputy Governor, government alone cannot drive economic prosperity, stressing that policies, infrastructure, and regulatory frameworks must be intentionally designed to attract and protect private investments. "No state can be economically viable without

creating an enabling environment for the private sector to thrive. When businesses succeed, jobs are created, revenues increase, and development becomes sustainable," Odey said.

He reaffirmed the commitment of the state government to reforms that promote ease of doing business, support small and medium-scale enterprises, and strengthen

partnerships with organized private sector groups. He highlighted ongoing initiatives such as the revamping of the Obudu Ranch Resort, the successful reclamation and ongoing restoration of the Tinapa Business and Leisure Resort, the partnership with Afreximbank for the \$3.5 billion Bakassi Deep Seaport Project, and African

Development Bank (AfDB) support for the construction of a Special Agro-Processing Zone in the state, among others.

Odey further noted that the administration of Governor Bassey Otu remains focused on leveraging private sector expertise and capital to unlock the state's economic potential.

Earlier, the NACCIMA President, Engr. Jani Ibrahim, commended the administration of Governor Bassey Otu for its urban renewal initiatives, infrastructure development, and improved security across the state. He described Cross River State as highly rated

among sub-national governments in terms of tourism potential and economic drive, applauded its openness to private sector engagement, and called for sustained collaboration to enhance industrialization, trade, and investment.

Assuring the Deputy Governor of NACCIMA's readiness to work closely with the state government to create opportunities for entrepreneurs and investors, Ibrahim appealed for government support for the Renewed Hope NACCIMA Economic Village and the One Billion Palm Tree Planting Project, which he said would create jobs and boost the national economy, in

alignment with President Bola Ahmed Tinubu's Renewed Hope Agenda.

The highlight of the event was the formal conferment of Rt. Hon. Dr. Peter Odey as a NACCIMA Ambassador, which was attended by former National President of NACCIMA, High Chief Bassey Edem, President of the Calabar Chamber of Commerce, Industry, Mines and Agriculture (CALCCIMA), Mr. Kelly Ayamba, members of his executive council, and other stakeholders.



# Northern Senatorial District Leadership for Growth & Development Tour Concludes in Yala LGA



**T**he Cross River State Northern Senatorial District Leadership for Growth and Development Tour on Wednesday concluded its maiden district-

wide engagement with a visit to Yala Local Government Area.

Led by the Chairman of the Forum, Chief Tony Undiandeye, the delegation met with traditional

rulers, chiefs, elders, and key stakeholders, where critical issues affecting the Northern Senatorial District were discussed. Chief Undiandeye emphasized the importance of

unity, mobilization, and collective commitment toward sustained development, particularly ahead of the 2027 general elections.

In his welcome address, the Chairman of Yala Local Government Area, Hon. Fred Okem, described Yala as a culturally rich area endowed with vast natural resources, including its well known natural salt. # Cross River Remains Meningitis-Free, Health Ministry Assures Residents

**T**he Cross River State Government has reassured residents that the state remains free of cerebrospinal meningitis, dismissing recent rumours of an outbreak and

urging the public to remain calm while relying on verified health information.

Speaking in response to media inquiries over alleged cases, including reports linked to the

University of Calabar Teaching Hospital (UCTH), the Commissioner for Health, Dr. Henry Egbe Ayuk, stated categorically that there is no epidemic or confirmed case of

cerebrospinal meningitis anywhere in the state.

Dr. Ayuk explained that cerebrospinal meningitis, which is commonly caused by bacterial or viral infections and often affects children in crowded settings, presents with symptoms such as high fever, body weakness and stiffness, and can be fatal if not promptly treated. He noted that the Ministry of Health immediately stepped up investigations following the circulation of unverified reports.

According to the commissioner, all samples collected from suspected or presumptive cases have returned negative, affirming

that Cross River State remains meningitis-free. "There is certainly no evidence of cerebrospinal meningitis in Cross River State," he stressed.

While giving the assurance, Dr. Ayuk said the state has maintained a high level of preparedness to respond to any public health emergency. He disclosed that disease surveillance teams are on alert across health facilities and communities, carrying out active case searches for early detection and prompt reporting.

He added that health promotion teams have intensified sensitization of caregivers, clinicians and

community members on the signs of meningitis and the importance of early presentation at health facilities.

The commissioner urged residents to disregard rumours capable of causing panic and to continue cooperating with health authorities by reporting any unusual symptoms through appropriate channels.

The assurance, he said, reflects the state government's commitment to protecting public health through proactive surveillance, transparency and sustained investment in disease prevention and response.

Located along Ogoja Road, the facility is being positioned as a premier centre for healing, equipped to deliver quality, people-centred



medical services. The project, spearheaded by the Commissioner for Health, Dr. Henry Egbe Ayuk, PhD, represents a significant stride in the state government's resolve to bridge healthcare gaps through modern infrastructure and improved access to care.



Following a recent site inspection, key project leaders converged to fine-tune the operational roadmap ahead of the hospital's formal take-off.

The inspection focused on ensuring that all wards, laboratories and critical service areas are fully ready for immediate clinical





use, with the overarching goal of transitioning the facility into a fully functional medical institution without delay.

Speaking to newsmen during the inspection, Dr. Ayuk emphasized the urgency attached to the project, stressing the administration's readiness to commence operations as soon as final

preparations are concluded. "Once everything is put in place, I will not waste time to come and start the operation," the commissioner assured.

Dr. Ayuk said staffing and security featured prominently in the review process. "The hospital has already secured a core team of professionals, including trained nursing graduates

and an experienced laboratory technician, as efforts intensify to close remaining personnel gaps. Particular attention is being given to establishing a robust 24-hour security system to safeguard the hospital's modern medical equipment and ensure uninterrupted service delivery. Plans are already





underway to strengthen security staffing to guarantee round-the-clock protection.”

In a bid to entrench community ownership and trust, the commissioner revealed that the Ministry of Health is mobilizing a wide network of stakeholders ahead of the hospital’s launch, adding that engagements are ongoing with the Obudu Local Government Council, faith-based

organizations such as the Catholic Church, Christian Association of Nigeria (CAN), and Pentecostal Fellowship of Nigeria (PFN), as well as the National Union of Road Transport Workers (NURTW), youth councils, and traditional leaders from Obukpa and Gbara communities of Obudu local government area.

“By drawing in these diverse groups, the Ministry aims to ensure broad awareness, collective

responsibility and sustained patronage of the facility. With final legal and administrative processes nearing completion, the General Hospital Obudu is poised to usher in a new era of accessible, and quality healthcare, accentuating the Cross River State Government’s commitment to improving the wellbeing of its people,” Ayuk concluded.

# CRSG to Commence 2026 Measles-Rubella and HPV Vaccination Campaign February 4



**T**he Cross River State Government has announced the commencement of the 2026 Measles-Rubella (MR) Vaccination Campaign, alongside the Human Papilloma Virus (HPV) vaccination, across the state.

The announcement was made by the Cross River State Primary Health Care Development Agency (CRSPHCDA) in

collaboration with the Ministry of Health and development partners. The vaccination exercise is scheduled to take place from Wednesday, February 4, to Sunday, February 15, 2026, across all 18 Local Government Areas of the state.

Speaking on the campaign, the Director-General of CRSPHCDA, Dr. (Mrs.) Vivien Mesembe Otu, disclosed that the Measles-Rubella

vaccine will be administered to children aged 9 months to 14 years, while the HPV vaccine will be given to adolescent girls aged 9 years to protect them against cervical cancer. She added that routine immunization services for children aged 0–23 months will also be provided during and after the campaign.

Dr. Otu explained that measles and rubella remain





major public health concerns, capable of causing severe fever, congenital malformations, blindness, miscarriage in pregnant women, and even death if not prevented. She emphasized that vaccination remains the most effective means of protecting children from birth against these diseases.

The campaign, she noted, forms part of a nationwide vaccination exercise by the Federal Government of Nigeria, aimed at strengthening immunity among

children and reducing the spread of vaccine-preventable diseases across the country.

According to the Director-General, vaccinations will be administered at health facilities, schools, churches, mosques, markets, recreational centres, palaces, motor parks, shopping malls, and other public locations where eligible children can easily be reached.

The agency assured residents that trained health workers will be deployed to all designated vaccination posts to

ensure a smooth, respectful, and child-friendly process. Parents and caregivers have been urged to seize the opportunity and ensure that no eligible child is left unvaccinated.

"All vaccines to be administered during the campaign are free, safe, effective, and fully funded by the government," the agency stated.

# NCCSALW Takes Custody of Arms Surrendered by 80 Repentant Militants in Cross River

**T**he National Centre for the Control of Small Arms and Light Weapons (NCCSALW), South-South Zone, has formally received a cache of arms

and ammunition surrendered by 80 repentant militants in Cross River State, marking another significant turning point in the state's drive to consolidate peace and security.

The weapons were handed over to the Centre on Monday by the Office of the State Security Adviser, following the successful disarmament of militants who had operated within





the creeks of Calabar and Akpabuyo Local Government Area.

Speaking to journalists in Calabar after receiving the arms, the Zonal Director of NCCSALW, South-South Zone, Alex Inemah Ebimiebo, PhD., commended the administration of Governor Bassey Edet Otu for according

priority attention to security matters, particularly the fight against the proliferation of arms and other weapons in the state.

Ebimiebo described the development as a testament to the effectiveness of the state government's peace-building initiatives and

collaborative security framework, noting that Cross River continues to stand out as one of the safest and most peaceful states in the country.

He also lauded the State Security Adviser, Major General Okoi Ubi Obono (rtd), for his strategic leadership and strong



collaboration with security agencies, which he said has translated into concrete gains in maintaining peace and stability across the state. He called for sustained synergy among all components of the state's security architecture to preserve and deepen the prevailing peace.

The NCCSALW Zonal Director disclosed that the Centre would immediately commence the statutory process for the destruction and disposal of the weapons received, in line with national and international best practices. He further urged Cross Riverians and residents of

the state to shun acts capable of threatening public peace, while reaffirming the Centre's commitment to curbing the spread of illicit arms in Cross River State and the entire South-South Zone.

The arms surrendered by the militants were earlier laid down under Operation OKWOK at the Atimbo Rear Area, in an exercise coordinated by the 13 Brigade of the Nigerian Army in collaboration with the Cross River State Government. The repentant militants, drawn from two camps, voluntarily embraced the state's amnesty programme, surrendering assorted weapons including rifles,

guns, ammunition, explosives, speedboats and other military hardware.

Representing the State Security Adviser at the event, Inspector Adoga David assured that the Otu-led administration would not relent in its commitment to safeguarding lives and property in the state. He noted that the government's prompt response to security concerns and sustained support for security agencies have continued to boost morale and yield positive outcomes in the maintenance of peace.

- 1** Obtain an Application Form at CRGIA's Office, Old Secretariat Road, Off Murtala Mohammed Highway, Calabar, Cross River State
- 2** Submit Application Form with Required Documents  
Fill and submit the form along with necessary documents, e.g. Registered Title Document, survey plan, identification, etc.
- 3** Assessment and Payment of Fees.  
The office will assess applicable charges, registration fees, processing fees, etc. Make the required payment.
- 4** Inspection and Publication (for private land)  
Property is inspected by LUAC officials  
Notice of application is published for 21 days to allow for objections.  
After clearance, Governor's Approval in Principle is obtained.
- 5** C of O (Certificate of Occupancy) Engrossment and Signing  
The Certificate of Occupancy is prepared (engrossed) and signed by the Governor or delegated authority.
- 6** Registration and Delivery  
Final registration is completed at the Lands Registry.  
Registered documents are delivered to the applicant (client).
