# C'River TCTI Secures World Bank IDEAS TVET Grant to Train 300 Youths in Tech Skills



In a major boost to the state's human capital development, the Cross River State government has launched a comprehensive skill acquisition program for 300 indigenous youths, funded by

a ₦90 million World Bank IDEAS TVET grant after a competitive bidding among several institutions in the country.

The initiative, facilitated by the Director-General of the Cross River State government-

owned Teachers Continuous Training Institute (TCTI) Biase, Professor Taoheed Adedoja, is designed to tackle youth unemployment by equipping young Cross Riverians with industry-standard technical

skills.

The six-month intensive program soon to be launched by the World Bank in conjunction with the Federal Ministry of Education-Abuja, will focus on high-demand ICT system sectors such as computer and telephone hardware repairs and maintenance, network system


installation and ICT-related technical training.

Speaking on the rollout, Professor Adedoja confirmed that the first phase of the project has already commenced. Last week participants underwent a rigorous three-day orientation, accreditation and finalization process and are scheduled to begin formal

training within the week.

Unlike traditional short-term training, this World Bank-funded Innovation Development and Effectiveness in Acquisition of Skills (IDEAS) project offers a sustainable path to entrepreneurship.

"The exercise will



happen simultaneously over six months and the TCTI is the Training Service Provider (TSP)," Professor Adedoja stated. "Upon completion, beneficiaries will receive professional certification and startup kits to enable them to operate independently as business owners."

To further support the trainees, the program includes a monthly monetary stipend for the duration

of the course, ensuring that financial constraints do not hinder their learning progress.

The 300 participants were selected through a collaborative process involving indigenous stakeholders from Biase Local Government Area. The project is being managed by Dr. Emmanuel Omini, TCTI's Acting Director of ICT as the service training manager.

Beyond the immediate benefit

to the 300 youths, the successful execution of this phase will open doors for TCTI to a larger strategic purpose due to the world class records set by the Director-General of the institution. A verified track record of the successful exercise will qualify Cross River State for an even larger World Bank funded project focused on training teachers on youth skill acquisition statewide.

## The Fundamental NRA Rules for Safe Gun Handling Are:

- **ALWAYS** keep the gun pointed in a safe direction.

- Be aware that certain types of guns and many shooting activities require additional safety precautions.

inspection of service arms and other operational equipment, in line with standard policing practices.

the exercise is strictly routine and should not cause alarm, despite the anticipated increase in police presence or the sound of gunfire during the training.

However, the Police advised residents, farmers and passersby to keep away from the shooting range and its immediate



surroundings for the duration of the exercise, noting that the precaution is necessary to prevent accidental exposure to stray bullets and to reduce psychological distress.



# Senator Eteng Williams Inaugurates Mkpani Road Project to Boost Rural Development



In fulfillment of his campaign promises to provide basic infrastructure capable of driving economic growth and rural transformation, the Senator representing Cross River

Central Senatorial District, Senator Eteng Williams, has inaugurated the construction of the Mkpani Ring Road in Yakurr Local Government Area of Cross River State.

Speaking at the

ground breaking ceremony, Senator Williams said the project forms part of his deliberate efforts to address infrastructure deficits across the senatorial district, add value to rural communities and

improve the living standards of his constituents.

He noted that access roads remain critical to economic growth, particularly for agrarian communities that depend on efficient transportation to move farm produce to markets. The senator assured residents that the Mkpani Ring Road was only one of several projects lined up to drive growth and transform communities across the district.

The inauguration ceremony, which attracted community leaders, traditional rulers and residents,

marked the official commencement of the two kilometre ring road linking the Aduma, Afaben and Ajere communities. The arrival of heavy duty construction equipment at the project site generated widespread excitement among residents, who described the initiative as timely and impactful.

Residents and stakeholders expressed optimism that the road would ease transportation challenges, improve market access for farmers and stimulate urban and commercial development within Mkpani and its surrounding communities.

In separate interviews, traditional rulers, community leaders and political stakeholders commended the initiative, describing it as a demonstration of responsive and people focused leadership that prioritizes grassroots development.

The Mkpani Ring Road is expected to complement the ongoing Mkpani to Agoi Road project being executed by the Cross River State Government and serve as a catalyst for broader economic activities in the area. With improved connectivity, the road is projected



to boost agricultural productivity, reduce transportation costs and support sustainable livelihoods.

Observers noted that the project aligns with Senator Williams' key campaign commitments to

improve rural infrastructure across the Cross River Central Senatorial District.

Other road projects facilitated by the senator include the grading of access roads in Iyamoyong, Okumurutet and Iyamitet in Obubra Local Government Area, the grading

of Agba One and Agba Two rural roads in Boki Local Government Area, the rehabilitation of Okundi, Irruan and Wula roads also in Boki, as well as the grading of the Abia to Bakassi Road in Etung Local Government Area.

# Cross River State Showcases Urban Mobility Vision at National Transportation Forum

The future of urban mobility in Cross River State took center stage at the recent National Transportation Stakeholders' Forum, convened in Transcorp

Hilton, Abuja by the Nigeria Governors' Forum with support from the World Bank.

Honourable Commissioner for Transportation, Hon. Pst. Ekpenyong

Cobham, presented a compelling case study detailing the state's ambitious plans and the findings of a crucial pre-feasibility study on its public transportation



sector.

The presentation, titled "CASE STUDY BRIEF FOR CROSS RIVER STATE URBAN MOBILITY PROGRAM," offered a comprehensive overview of the state's commitment to modernizing its

transportation networks, encompassing both land and marine components.

The core of the discussion revolved around the outcomes of a detailed pre-feasibility study that meticulously examined the

current state of public transportation across four key urban centers.

These strategic locations – Calabar, the State Capital; Ikang in the Southern Senatorial district; Ikom in the Central district and Abakpa in the Northern district – were chosen to represent the diverse needs and challenges across all three senatorial districts of Cross River State.

Discussions also delved into various aspects of the study, including the procurement of needed infrastructures, such as acquisition of electric city buses, tricycles

and motorcycles, with recharging stations already put in place for the adoption of best practices in transportation management.

Hon. Pst. Ekpenyong Cobham articulated the state's vision for an integrated, efficient, and sustainable urban mobility system.

The study aimed to provide a clear and data-driven understanding of the existing infrastructure, operational efficiencies, and areas requiring significant intervention.

The pre-feasibility study's findings highlighted the critical need for strategic investments and

policy reforms to enhance the quality, accessibility, and safety of public transportation for the citizens of Cross River State.

The presentation underscored the potential for a revitalized transport sector to drive economic growth, improve quality of life, and foster greater connectivity within the state and abroad.

The National Transportation Stakeholders' Forum provided a vital platform for Cross River State to share its innovative approaches and to engage with national and international partners.

The collaborative environment fostered by the Nigeria Governors' Forum and the World Bank allowed for constructive dialogue and the potential to forge partnerships that could accelerate the implementation of the state's urban mobility programs.

The participation of Cross River State at this high-level forum signals a proactive stance in addressing the complexities of urban transportation and a dedication to building a more connected and prosperous future for its residents.

# C' River, Submit Bank Begin Talks For Calabar Branch

The Cross River State Government has taken a significant step toward expanding financial services in the State, following high-level discussions with Submit Bank on the establishment of a branch in Calabar.

The State Commissioner for Commerce, Dr. Abigail Orok Duke, disclosed this shortly after a meeting with the Managing Director of Submit Bank, Alhaji Sirajo Salisu, in Abuja, where both parties explored opportunities for strengthening

commercial and banking activities in Cross River State.

Discussions at the meeting centered on improving access to financial services, supporting small and medium-scale enterprises, and enhancing the overall business environment in the state. The talks align with the Cross River State Government's broader strategy to attract private sector investment and stimulate economic growth.

Following the meeting, Alhaji Salisu assured the State Government of Submit Bank's commitment to

proceed with plans to establish a branch in Calabar.

He noted that the move would bring banking services closer to residents and business owners, while also contributing to the state's economic development.

The proposed Submit Bank branch is expected to boost local commerce, create employment opportunities, and provide improved financial inclusion for individuals and businesses across Cross River State.

The beneficiaries received the scholarship on Saturday, January 24, 2026, at the Sir Thompson Egbe Educational Foundation, Anong, Abi Local Government Area, in what was

described as a memorable moment for students of Yakurr origin.

Speaking at the event, Dr. Osogi said the scholarship award was a fulfilment of the vision he unveiled in October 2025,



during which similar support was extended to students from Abi Local Government Area.

According to him, the initiative was driven by his passion for education and commitment to giving back to society. "I consider it a privilege to

support students, not because I have so much, but because giving is an innate part of who I am," he said.

# C'River Intensifies Drive To Improve Education, Shuts Down More Illegal Schools



The Cross River State Government has sustained its commitment to improving the quality of education with the shutdown of more illegal schools across the 18 Local

Government Areas of the State.

The ongoing enforcement exercise, led by the State Ministry of Education, is part of the government's broader education reform agenda

aimed at sanitizing the sector and ensuring that only duly approved schools operate within the state.

Speaking on the exercise, the Commissioner for Education,



Senator Professor Stephen Odey Esq, said the action aligns with the Ministry's directive to clamp down on schools operating without the mandatory

Approval to Operate (ATO).

According to him, the initiative is designed to safeguard the academic future of pupils and

students, noting that many unapproved schools fail to meet the minimum standards required for effective teaching



and learning.

Professor Odey disclosed that over one hundred and fifty sixth (156) illegal schools were shut down across the state in 2025, adding that the exercise would continue this year to ensure full compliance with government regulations.

“The sanitization of illegal schools is for the betterment of our children. Every school proprietor must do the right

thing by obtaining the Approval to Operate (ATO). Any proprietor who reopens a closed school without authorization will be duly penalized,” the Commissioner warned.

As part of the ongoing exercise

- Peculiar International Nursery and Primary School, Efut Uwanse Layout, Calabar South, was shut down for operating illegally.

The Commissioner reaffirmed the

Cross River State Government’s unwavering commitment to restoring quality education and ensuring that all schools in the state meet approved standards, in line with the administration’s vision of providing a sound and competitive educational system for all.

# Governor Otu Flags Off Construction of Phase II of 17km Boki East-West Road



**A**s part of ongoing efforts to enhance connectivity and stimulate socio-economic development in rural communities, and in fulfillment of his administration's commitment to

improving road infrastructure across Cross River State, Governor Bassey Otu on Thursday performed the groundbreaking ceremony for the construction of the second phase of the 17-kilometre Boki East-West Road at Onitsha Farm in

Boki Local Government Area.

Speaking at the ceremony, the Governor, who was represented by his deputy, Rt. Hon. Dr. Peter Odey, described the road project as a critical intervention designed to open

opportunities.

united, be their brother's keeper, and work collectively for the growth and success of the party in Obudu LGA. In




furtherance of this commitment, he supported the meeting with the sum of ₦10 million, while Senator Eteng Jonah Williams contributed ₦1 million.
