# Gov. Otu Swears In Egbung as Bekwarra Chairman, Calls for Unity, People-Centred Governance



Governor of Cross River State, Senator Bassey Otu, Monday swore in Hon. Egbung as the substantive Chairman of Bekwarra Local

Government Area, charging him to lead with humility, unity of purpose and commitment to service.

The swearing-in ceremony, which marked the formal

resolution of the leadership crisis in the council, was also used by the governor to set the tone for governance in the New Year, as he welcomed stakeholders and

guests with warm New Year wishes.

Governor Otu emphasised the strategic importance of local government administration, describing it as the tier of government closest to the people and critical to grassroots development. He said the All Progressives Congress (APC) places premium value on effective local governance because of its direct impact on communities, families and everyday livelihoods.

Reflecting on the transition in Bekwarra, the Governor commended party leaders, stakeholders and government

institutions for managing the process peacefully and orderly, without disruption. He praised the maturity displayed by the APC leadership in the local government, noting that their conduct helped preserve unity and stability.

“Position is not given for you to exert power or become an emperor. Position is for you to serve the people,” Otu said, reminding the new chairman that leadership is a call to responsibility, compassion and accountability, especially to the most vulnerable in society.

The governor expressed confidence in Egbung’s capacity to deliver, citing his

experience, character and steady performance while acting in the role. He described the new chairman as a product of due process who understands governance from the ground up and has earned the trust and support of his people.

Otu further revealed that Bekwarra remains a key part of the administration’s economic vision for Northern Cross River, assuring that ongoing and future initiatives would reposition the area for growth and shared prosperity. He called for sincerity of purpose, seriousness in governance and collective commitment to



development.

As he concluded, Governor Otu congratulated Hon. Egbung and his family, urging them to see the new responsibility as service to God, the state and the people of Bekwarra, while expressing optimism that better days lie ahead for Cross River State.

In his response, the newly sworn-in Chairman of Bekwarra Local Government Area, Hon. Egbung

Odama Egbung, expressed profound gratitude to God for what he described as an eventful and fulfilling day, assuring the people of Bekwarra and Cross River State of his readiness to serve diligently and responsibly. He said his administration would be guided strictly by the rules of engagement, transparency and commitment to the welfare of the people.

Describing the new year as one of renewed energy

and purpose, Egbung urged the people of Bekwarra to prepare for hard work and collective progress, stressing that the time for complacency was over. He noted that leadership to him simply means service, adding that he has lived a life dedicated to serving others and would continue in that spirit as chairman of council.

# C'River Tourism Ministry Graced Offiong ye Effiom 3rd Revived Traditional Wrestling

In a renewed effort to preserve cultural heritage and promote unity among the people, the Akpabuyo Local Government Community orchestrated the third version of traditional wrestling, an age-long sport deeply rooted in the

customs and identity of the community.

The historic event which took place on the 3rd of January, 2026, at the Ikot Effiong Essien, Edet Nsa Ward in Akpabuyo Local Government Area, Cross River State, had Pastor Mrs Eme Affiah, Permanent

Secretary Ministry of Tourism, Arts And Culture and some Management Staff of the Ministry in attendance.

This event held amid colourful displays of culture, drumming, chanting, and traditional dances which



accompanied the bouts, creating a festive atmosphere that captivated spectators filled with elders, youths, cultural troupes, and visitors from neighbouring communities and tribes like the Bakassi, Obutong, Bayelsa and Rivers State.

This traditional wrestling known as Mbok in their Local dialect was once a major feature of communal festivals and rites of passage but had declined over the years due to insecurities, modernization and dwindling interest among the younger generation.

Speaking in an interview Honourable Bassey Bassey, honorable Member representing Akpabuyo Local Government Area, emphasized that the revival of the traditional wrestling began following Governor Bassey



Edet Otu's People first mandate and drive to maintain peace and stability in the State and part of a broader vision to reconnect the people with their cultural roots, marking significant steps towards cultural renaissance and reaffirming the community commitment for preserving it's rich culture.

He described the sport as more than physical combat, noting that it symbolizes courage, discipline, respect,

communal pride strength and bonding which will help curb social vices by engaging youths in meaningful cultural and sporting activities, while also promoting tourism and cultural education.

“Traditional wrestling is a heritage handed down from our ancestors. By reviving it, we are not only preserving our culture but also teaching our youths values of strength, honour, and unity,” he said.

Bassey called for

the event to be institutionalized as an annual festival which it was, with greater support from Government, cultural organizations and relevant government agencies.

Highpoint of the event was a competition of skilled wrestlers from different age groups and wards, each demonstrating strength, technique, and sportsmanship.

# Tax laws: No bank account will be debited, Oyedele assures



The Federal Government has reassured that the new tax reforms, set to take effect from 1 January

2026, will not involve automatic debits from personal bank accounts, and individuals do not need to provide

explanations for transfers.

Addressing widespread misconceptions surrounding the

reforms, the Chairman of the Presidential Committee on Fiscal Policy and Tax Reforms, Mr. Taiwo Oyedele said on Channels Television's special programme on Tuesday said: 'People think that the government will debit their bank accounts from next year, and how they even came up with that, I have no idea. Nobody will debit your account for any amount you transfer. Whether it's a billion or one thousand naira, at the end of the year, you tell the government yourself'.

Explaining the process and emphasising its simplicity and transparency, Oyedele said that

the new tax system simplifies reporting and ensures fair taxation for small businesses, without burdening the vulnerable.

'You know what constitutes your income and what doesn't. So you tell the government: 'This is my income and here is the tax'. If you are exempted, you simply declare: 'This is my income, and I am exempted from tax'. It is a very simple process that we are simplifying further.

'One of the biggest benefits is that if you run a small business as a sole proprietor, an enterprise, or you are just hustling, the system will no longer be regressive, taxing the vulnerable more. We've made

it progressive', he said.

Earlier on Tuesday, President Bola Tinubu confirmed that the implementation of the new tax laws will commence as scheduled, despite criticisms from political figures, opposition groups, and labour unions.

Tax reforms: Govt will not deduct from bank accounts, Oyedele assures

Tax ID not mandatory for all Nigerians Oyedele In a statement, President Tinubu said the laws are not designed to increase taxes but

to support a structural reset, promote harmonisation, protect citizens' dignity, and strengthen the social contract.

'The new tax laws, including those that took effect on 26 June 2025, and the remaining acts scheduled to commence on 1 January 2026, will continue as planned.

'These reforms are a once-in-a-generation opportunity to build a fair, competitive, and robust fiscal foundation for our country', he said.

The president called on all Nigerians to support the reforms as they take effect in the coming days.

The reforms, signed into law in June 2025, aim to simplify Nigeria's tax system, broaden the tax base, and protect low-income earners and small businesses.

Key provisions of the tax reforms include full personal income tax exemption for those earning ₦800,000 or less, while higher earners face progressive rates capped at 25%.

Small businesses with turnover under N100 million are exempt from company tax, VAT, and the new development levy, and corporate tax for larger firms drops from 30 to 25%.

VAT remains at

7.5% with exemptions for essentials, and revenue collection will be centralised under the Nigeria Revenue Service.

Despite some controversy and court challenges, the government has clarified that ordinary citizens will not face automatic debits or new taxes, and exemptions cover minimum wage earners, pensions, gifts, remittances, and diaspora Nigerians.

The reforms are designed to ease tax burdens, support small businesses, and promote a fairer, more transparent tax system while driving economic growth, it said.



# SACA DG Extends Hearty New Year Greetings to Gov. Otu, Bishop Eyoanwan, and Cross Riverians

# Over 181,000 Condoms Distributed as Cross River State Concludes 9th Edition of “Wise Up” Youth Health Campaign at Carnival Calabar

The Cross River State Government, through the State Agency for the Control of AIDS (CR-SACA) and the Ministry of Health, with support from the United Nations Population Fund (UNFPA) and

other partners, has successfully concluded the 9th edition of the “Wise Up Carnival Calabar” Youth Health Campaign.

The month-long campaign, which ran from December 1 (World AIDS Day) to December 29,

2025, was implemented alongside the annual Calabar Festival and the iconic Carnival Calabar, popularly known as Africa’s biggest street party.

Since its introduction in



2016, the Wise Up Carnival Campaign has become a strategic platform for the State Government to reach adolescents

and young people with sexual and reproductive health services, HIV prevention messages, and other essential

healthcare services, particularly during the festive season when large numbers of visitors troop into the State.



The 2025 edition of the campaign was implemented under the theme "Your Choice Leaves Traces," aligning with Carnival Calabar's 20th anniversary



theme, "Traces of Time." The message emphasized the importance of responsible decision-making and the long-term health implications of choices made during periods of celebration.

A major highlight of the campaign was the establishment of a Wise Up Health

Booth at the Calabar Christmas Village, one of the busiest social and entertainment centres during the festive period. The booth provided youth-friendly and stigma-free access to integrated health services, outside the traditional hospital setting.

Over a 21-day period, the campaign recorded

impressive results. Nearly 100,000 persons were reached with direct health education, behavioural counselling and sexual and reproductive health information and services. More than 181,824 male and female condoms were distributed, while 1,189 persons received



HIV testing, with all positive cases promptly linked to care and treatment.

Other services provided included malaria and

hepatitis screening, blood pressure and blood sugar checks, family planning services, pregnancy testing, medical consultations and referrals, as well as

counselling and referral services for survivors of gender-based violence.

Implementation of the campaign was driven by over 75



trained volunteers, including health personnel from the Cross River State Ministry of Health, youth peer educators, civil society representatives and creative artistes. During the grand carnival parade on

December 29, volunteers participated as a non-competing "Wise Up Health Band," engaging spectators along the 12-kilometre carnival route with health messages, condom distribution and advocacy for increased investment in the

health sector, particularly in the context of declining donor funding.

Flagging off the campaign earlier in the month, Governor Bassey Otu, represented by the Commissioner for Health, Dr. Henry



Egbe Ayuk, reaffirmed the State Government's commitment to sustaining integrated health service delivery during major public events.

Speaking on the campaign, the Director-General of CR-SACA, Dr. Charles Iwara, described Wise Up as a cost-effective

and practical approach to maintaining HIV prevention and youth health services during periods of high mobility.

Also speaking, Mr. Oke Nteigbanam, Adolescent SRH/HIV Analyst with UNFPA in Cross River State, noted that the carnival provided a unique opportunity

to reach young people in a relaxed, stigma-free environment.

"As young people celebrate during the festive period, the Wise Up Campaign ensures they also receive the right information and services to make informed choices about their health," he said.



As Carnival Calabar marked its 20th anniversary, the successful implementation of the 2025 Wise Up Campaign further demonstrated the Cross River State Government's commitment to promoting adolescent and youth health, strengthening HIV

prevention efforts, and ensuring that cultural celebrations go hand in hand with responsible health choices.

The achievements recorded underscore the critical need for increased and sustained investment in adolescent and

youth health, to consolidate gains and ensure the long-term impact of public health interventions across the State.


The Cross River State Commissioner for Environment, Obol Moses Osogi, on Monday, January 2, led an entourage to the traditional marriage

# New Year Message: Gov Otu Reaffirms Unity, Highlights Key Milestones in 2026



Cross River State governor, Senator Bassey Edet Otu, has called on Cross Riverians to sustain unity and collective purpose as the surest pathway to shared prosperity, declaring that the state's steady progress is the fruit of inclusive governance and deliberate

collaboration.

In his 2026 New Year message entitled: "Together, We Flourish," the governor expressed profound gratitude to God for life and preservation, noting that many who began 2025 with the state did not live to see the New Year.

Reflecting on the

journey so far, Governor Otu reminded the Cross Riverians that from the outset of his administration, he made it clear that governance would be participatory. "I was not pretentious of having all the answers," he said, stressing that development could only be achieved through collective

effort. This conviction, he explained, birthed the "Think Cross River" initiative—an attitudinal reorientation project urging citizens to place the state's interest above personal considerations.

The governor said this philosophy of togetherness informed the constitution of key advisory and governance structures, including the State Elders' Forum (SEF), the Economic Management Team (EMT), the state Strategic Policy Advisory Committee (SPAC), and the Party Caucus Forum (PCF). According to him, these bodies were designed to provide both wisdom and

technical guidance in steering the affairs of the state.

He commended members of the various bodies for their shared vision and cooperation, noting that his cabinet reflects the diversity of Cross River State. "Every ethnic nationality, every local government area and every senatorial district is a stakeholder in my administration," Governor Otu stated, describing these steps as "verifiable indices of an inclusive government."

Otu said the unity of purpose has yielded tangible dividends, evident in improved livelihoods and visible achievements across sectors. He said the gains recorded in the past two and a half years

are the direct outcome of collective resolve and consistent teamwork.

On agriculture, the governor disclosed that his administration has deliberately repositioned the sector as the backbone of the state's economy. He announced the establishment of crop-specific clusters across the state, with rice in Ndok Ogoja, cassava in Odukpani and Obubra, oil palm in Boki and Akamkpa, cocoa in Etung and Ikom, alongside coffee cultivation statewide. He also revealed that a Value Chain Policy Strategy committee has been inaugurated for cocoa, oil palm and coffee.

To enhance productivity, Governor Otu said 108 three-wheel tractors have been distributed to farmers' cooperatives, while 100 fishing and commercial boats were provided to riverine communities. He added that oil palm estates are being repositioned through Public-Private Partnerships, while digital soil mapping has been completed to guide prospective agro-investors. "We recently performed the groundbreaking for the Special Agro-Industrial Processing Zone in partnership with the African Development Bank," he noted.

On infrastructure, the governor described the

Bakassi Deep Seaport as the state's most significant economic game-changer. He recalled that following comprehensive technical studies, the Federal Executive Council approved the project with an initial capital outlay of \$2.27 billion. "On December 17, 2025, we received the Certificate of Compliance—the final approval document. We are now counting days to the formal groundbreaking," he announced.

Governor Otu also revealed that Cross River State has successfully reclaimed ownership of the Tinapa Business and Resort Limited from AMCON after years of inactivity. He disclosed that

discussions are already underway with investors, particularly in agriculture-related ventures, to revive the iconic facility.

The governor urged Cross Riverians to remain united, stressing that togetherness remains the key to sustained progress. "To come together is the beginning, to stay together is progress, and to work together is success," he said, wishing the people a prosperous New Year and God's manifold blessings. He reaffirmed his commitment to leading a government anchored on unity, continuity and shared prosperity.

# FG halts plans to cede 10,000 hectares of land to Cameroon



The Federal Government has halted plans to cede more than 10,000 hectares of Nigerian land to neighbouring Cameroon following concerns over improper boundary demarcation.

The lawmaker representing Ikom/Boki Federal

Constituency, Mr Victor Abang, disclosed this during a constituency briefing on Wednesday at Keyang II in Boki Local Government Area of Cross River State.

Abang said the proposed cession was linked to the 2002 International Court of Justice

ruling, which stipulated that the Nigeria–Cameroon boundary be defined in line with the 1913 Anglo-German Treaty.

He explained that a joint implementation committee attempted to demarcate the boundary without due regard to



established colonial boundary features, including Pillar 113A, a recognised demarcation point between both countries.

According to him, failure to observe the historic boundary would have resulted in the loss of more than 10,000 hectares of Nigerian territory, including parts of Biajua and Danare communities in Boki.

Abang said he presented a motion on the matter on July 5,

2023, which was deliberated upon by the House of Representatives, leading to the suspension of the exercise pending a comprehensive review.

The lawmaker also presented a two-year scorecard titled "The Banjuere", highlighting projects such as a mini stadium, telecommunication masts linking 35 communities, and N300 million worth of medical equipment.

He further disclosed that he

sponsored the National Park Service Amendment Bill, aimed at environmental conservation and the establishment of the Okwangwo National Park Unit as an independent entity.

Abang said the bill was expected to enhance the economic, ecological and developmental value of the Boki forest and its surrounding communities.

# Akpabio Reaffirms Senate's Commitment to National Stability in 2026



The President of the Senate, Godswill Obot Akpabio, GCON, has expressed confidence that 2026 will be a year of renewed hope and steady national progress, anchored on institutional responsibility, legislative diligence, and collective resolve.

In his New Year

message, signed by his Special Adviser on Media and Publicity, Hon. Eseme Eyiboh, Senator Akpabio acknowledged the resilience of Nigerians and underscored the central role of the National Assembly—particularly the Senate—in sustaining democratic stability, promoting accountability, and advancing the

# Akposi Presents N13.39bn “Budget of Consolidation” to Akamkpa 8th Legislative Assembly



The Chairman of Akamkpa Local Government Council, Hon. (Ophot) Felix Akposi KSJI, has formally presented the 2026 Appropriations Bill to the 8th Assembly of the Akamkpa Legislative Council, unveiling a ₦13,393,409,690

Budget of Consolidation aimed at deepening development, strengthening the local fiscus, and sustaining people focused governance.

Presenting the budget on the 30th of December, 2025 during a plenary session of the House, Hon. Akposi explained that the

2026 estimate represents a marginal increase of ₦2,367,355,221 over the revised 2025 budget. He noted that the proposal was crafted in strict alignment with the Medium Term Expenditure Framework and reflects the administration's resolve to



reposition Akamkpa as a preferred tourist destination with a vibrant economy, enlightened citizenry, and a stable atmosphere of peace and security.

According to the Chairman, the budget is both

consolidative and forward looking, designed to complete ongoing projects while initiating new interventions consistent with the administration's guiding mantra of "Serve the People."

"This budget is a continuum of our

promise to the people of Akamkpa," Hon. Akposi stated. "It is anchored on fiscal prudence, equity, and the responsible management of our commonwealth. We are consolidating on gains already recorded while



laying a solid foundation for inclusive growth and sustainable development.”

He outlined the projected revenue sources to include an opening balance of ₦232,380,10, internally generated revenue of ₦151,868,833, SSA of ₦10,500,000, FSA of ₦2,907,168,031, and total recurrent revenue of ₦3,943,229,361. Recurrent

expenditure is projected at ₦3,943,229,361, while capital expenditure stands at ₦9,450,180,329, underscoring the administration’s emphasis on infrastructure and long term value creation.

The sectoral allocation of the budget shows a deliberate balance across critical areas. The Social Services Sector is allocated ₦2,163,375,825

representing 27 percent, while the Economic Sector receives ₦2,152,883,478 also at 27 percent. The Environment and Regional Development Sector is earmarked ₦1,178,006,972 accounting for 23 percent, with General Administration proposed at ₦1,238,269,600, bringing the total allocation to 100 percent.



On capital revenue receipts, the Chairman disclosed that transfers from consolidated revenue fund charges amount to ₦799,496,440, opening balance ₦38,972,709, value added tax ₦2,060,908,442, excess crude ₦12,500, exchange rate differential ₦328,010,885, government share of foreign exchange ₦75,465,780,

electronic money fund ₦138,476,365, ecological fund ₦343,843,255, non oil revenue ₦108,416,384, solid mineral revenue ₦18,696,450, and other capital receipts ₦15,550,000. Grants and loans were recorded as nil, bringing total capital funds to ₦2,341,343,830.

Extracts from the budget further indicate a 31 percent contribution

from the joint account, statutory contributions to Cross River State reserved funds, counterpart funding obligations, capital expenditure commitments, contingency provisions, and projected surplus or deficit positions, all structured to preserve macro stability at the local level and ensure consensus ad idem between the executive and legislature.

Formally laying the budget before the House, Hon. Akposi appealed for partnership and expeditious consideration.

"I respectfully seek the collaboration of this Honourable House to give this budget the necessary scrutiny and timely approval," he said. "Together, we can chart a new course for Akamkpa and translate these figures from the exchequer into tangible benefits for our people."

Responding on behalf of the legislature, the Leader of the 8th Assembly, Hon. (Princess) Magdalene Ekpe, commended the Chairman for what she described as proactive and

visionary leadership.

"Your visible imprint in project implementation and delivery is commendable," she said. "It is the prime objective of this House to synergize with you to ensure that the people of Akamkpa truly enjoy the dividends of democracy and your sacred commitment to service."

She further described the proposed budget as people oriented, assuring the Chairman of the Assembly's readiness to undertake diligent deliberations and ensure a smooth passage.

"This budget reflects the aspirations of our constituents," Hon. Ekpe added. "This House will do the needful so that

every provision captured is translated into real impact for the people of Akamkpa."

The high point of the session was the formal presentation of the 2026 Budget of Consolidation to the 8th Assembly, followed by a brief photo session, marking another significant step in the council's ongoing quest for prudent appropriation, responsible governance, and sustainable development.



**CLARIFICATION ON REGULATIONS FOR TAKING OF PHOTOGRAPHS AT THE CROSS RIVER STATE LIBRARY COMPLEX**

The attention of the Government of Cross River State has been drawn to the unregulated and uncoordinated taking of photographs and making of Videos by users and visitors to the recently re-opened Cross River State Library Complex.

These unwholesome trends have continued to remain an issue of great concern to the Management of the Cross River State Library and the Government wishes to address them in the overall interest of the Public as follows:

1. The Cross River State Library Complex remains a public institution owned by the Cross River State Government. It has not been sold, leased, or transferred to any individual or private entity.
2. Government wishes to however note that certain sections within the State Library Complex -such as the Café and Multi-Purpose areas; are managed spaces established to promote sustainability, orderliness, and the protection of public assets.
3. The already introduced guidelines regulating photography and videography within designated areas of the Library Complex were introduced solely to preserve a conducive learning and research environment for users. These measures were further intended to reduce overcrowding, limit noise and distractions as well as prevent the misuse or damage of Library facilities.
4. Government wishes to emphasize that as a public Library, maintaining quiet study conditions and safeguarding resources remains a core responsibility of Management of the Library.
5. Again, Government recognises the fact that unrestricted filming and photography can lead to congestion and disruption of services for other Library Users.
6. In the light of the above, all clients-group or Individual, MUST give prior

notification and receive formal approval from the Library Management to guarantee seamless identification and Commercial Photography in the Complex.

7. Government further directs all clients and users to strictly adhere to the guidelines to correct all noticeable inconsistencies, enhance engagements and avoid congestion in the Library. They are also to note that these standardised guidelines are not intended to penalise Library Clients and Visitors but to make the Library more accessible, orderly, serene and beneficial to all members of the public.

Finally, Government sincerely appreciates the support so far and solicits for continued cooperation so that together with the Library Management, improved service delivery and transparency will be achieved in line with international best practices.

# DG CRSEMA Remind Cross Riverians Of Extant Laws Against Indiscriminate Bush Burning

The Director General, Cross River State Emergency Management Agency CRSEMA, Mr Antigha Gill has reminded the people of the State of the extant laws against indiscriminate bush burning and it's consequences.

The DG who was speaking in an interview with correspondents in his office emphasized that the State Government has activated all law enforcement apparatus including the traditional governing structure to keenly watch out for culprits for arrest and prosecution.

Mr Gill lamented the progressive destruction of the State flora and fauna in massive scale through indiscriminate bush burning especially during the dry season.

He disclosed that 2025 recorded large farm lands



and reserve forests as well as crops worth millions of Naira consumed by unwarranted inferno occasioned

by careless use of fire which has grossly affected the socio-economic landscape of the State.

According to him, while he acknowledged that rural farmers require discreet burning of farmlands for crop cultivation igniting portions not needed is uncalled for culminating in economic waste.

He challenged the leadership at the grassroots level to support government in the campaign against indiscriminate bush burning by monitoring their subjects with a view to checkmating the ugly trend.

The DG also expressed his worries over the high rate of urban fires which has in recent times consumed property worth billions of Naira leaving in it



trails lost of lives and massive displacement of people.

He attributed the causes of the incidences to electrical defaults, cooking gas explosions and improper handling of other combustible materials stressing that such sad situations can be controlled with

commitment by citizens.

Mr Gill said that in due course the consistent synergy with fire fighting outfits in the State will converge in intensive public training on the prevention and Management of accidental infernos.

The DG used the opportunity to commend the State

Governor Apostle Senator Prince Bassey Edet Otu for his dogged efforts towards revamping the Fire Service architecture across the State.

**ILLEGAL OPERATIONS OF LOTTERY AND GAMING BUSINESSES IN CROSS RIVER STATE**

The attention of the Government of Cross River State has been drawn to the illegal and deceptive operations of some Lotteries and Gaming Companies and Organisations in Cross River State without proper registration and authorisation from the Cross River State Lotteries and Gaming Agency established by Law No 3. of 2024.

These illicit operations being perpetrated by some Lotteries and Gaming businesses, both those with physical office addresses and those operating online, are a flagrant violations of the Supreme Court Judgement of 22nd November, 2024 which nullified the National Lotteries Act 145 Laws of the Federation of Nigeria 2005 and vested the regulatory powers over Lotteries and Gaming businesses on States of the Federation of Nigeria.

The Government of Cross River State wishes to restate categorically here that by the Cross River State Lotteries and Gaming Law assented to by His Excellency, Governor Bassey Edet Otu on the 12th of May, 2025, only the Cross River State Lotteries and Gaming Agency is vested with powers to issue Licences and regulate Lotteries and Gaming businesses and Services in any part of the State, be it a physical office or online.

For the avoidance of any doubt, these Lotteries and Gaming activities include Online Sports Betting, Casino Games, Public Online Lotteries, Pools Betting, Raffle Draws, Scratch Cards, Interactive Games and any other game of chance where a stake and potential winning is involved.

Government hereby enjoins all Radio and Television Stations operating in the State to please liaise effectively with the Advertising Regulatory Council of Nigeria (ARCON), the Cross River State Signage and Advertising Agency (CRISAA) to demand for the Agency's Operational Permit before accepting to publicize their businesses on air as paid advertisements.

Finally, the Government sincerely appreciates and thanks all Lotteries and Gaming Companies and Organisations that have complied with the Law and solicits the understanding and cooperation of all concerned while also making it clear that violators/defaulters shall face the full wrath of the law.

Obtain an Application Form at CRGIA's Office, Old Secretariat Road, Off Murtala Mohammed Highway, Calabar, Cross River State
- 2**  
Submit Application Form with Required Documents  
Fill and submit the form along with necessary documents, e.g. Registered Title Document, survey plan, identification, etc.
- 3**  
Assessment and Payment of Fees.  
The office will assess applicable charges, registration fees, processing fees, etc. Make the required payment.
- 4**  
Inspection and Publication (for private land)  
Property is inspected by LUAC officials  
Notice of application is published for 21 days to allow for objections.  
After clearance, Governor's Approval in Principle is obtained.
- 5**  
C of O (Certificate of Occupancy) Engrossment and Signing  
The Certificate of Occupancy is prepared (engrossed) and signed by the Governor or delegated authority.
- 6**  
Registration and Delivery  
Final registration is completed at the Lands Registry.  
Registered documents are delivered to the applicant (client).
