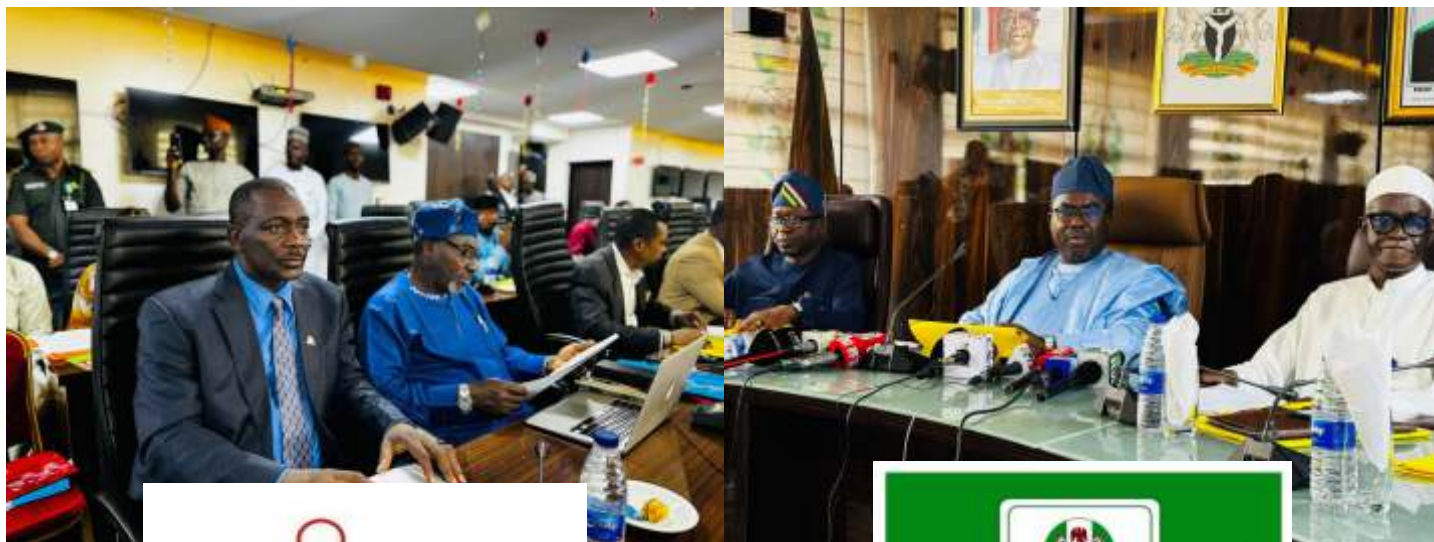

NIPR Arms INEC with Strategy to Turn Skeptics into Voters Ahead of 2027 Elections



The Nigerian Institute of Public Relations (NIPR) has unveiled its homegrown Strategic Electoral Intelligence Framework to help the Independent National Electoral Commission (INEC) tackle eroding public

trust and revive voter turnout, which has fallen sharply since 2023.

"This framework goes beyond technology, providing INEC with targeted insights and strategic tools to restore confidence, manage perceptions, and

strengthen engagement across all stakeholders," NIPR Acting President, Professor Emmanuel Samu Dandaura said.

Professor Dandaura, made the recommendation



on Wednesday at INEC headquarters in Abuja during the Commission's first-quarter consultative meeting with media executives.

Prof. Dandaura emphasised that successful elections are achieved not through technology alone,

but through a holistic communication strategy that addresses credibility concerns and strengthens citizens' confidence in the

process.

"Unmet expectations from past elections have created a perception challenge that





cannot be solved by technology alone. We need a deliberate communication strategy that restores trust and positively shapes public perception," he said.

While acknowledging INEC's progress in technological innovation during

the 2023 elections, Prof. Dandaura noted that glitches during the process heightened public scrutiny and lowered citizens' confidence.

"As an Institute, we are pleased that INEC is taking steps to bridge the trust gap that widened after 2023. Improvements to

the IRev system address some operational gaps, but they cannot alone restore confidence. We must engage the minds of Nigerians and international observers whose past experiences have eroded trust in the electoral process. Ahead of the 2027 elections, a carefully



designed strategic communication approach is essential to measure and manage public perception," he explained.

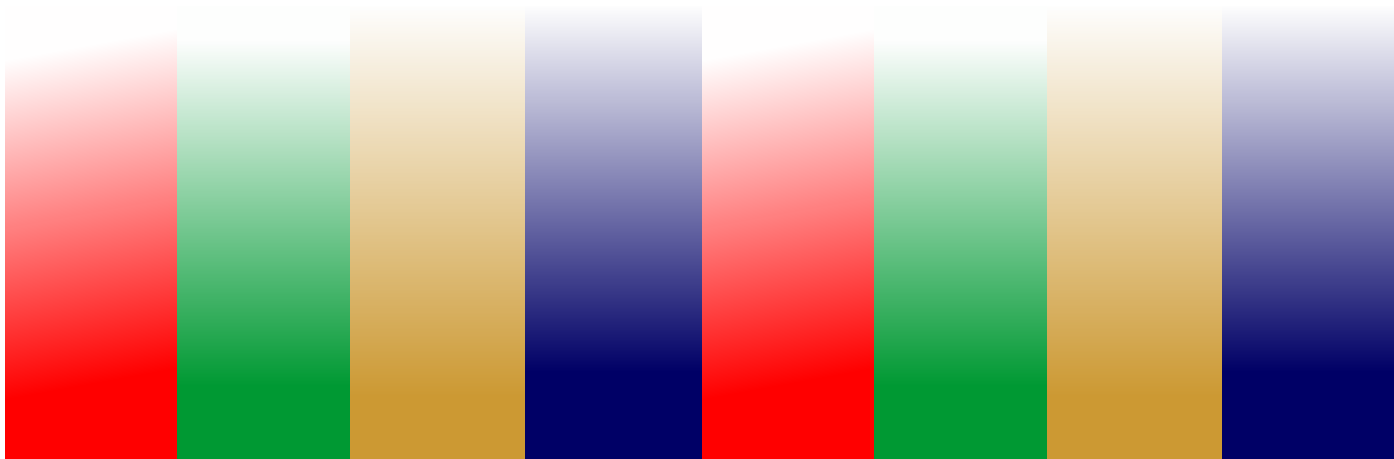
Prof. Dandaura cautioned INEC against using propaganda to protect its reputation and outlined the

Strategic Electoral Intelligence Framework.

The framework he noted will map low-confidence "Reputation Desert Zones," provide region-specific insights, a National Electoral Perception Index, and dashboards to guide communication and counter

misinformation. A three-wave longitudinal survey he added will track changing perceptions, enabling proactive, data-driven interventions.

Responding, INEC Chairman Professor Joash Amupitan commended NIPR for the initiative



and expressed the Commission's readiness to collaborate.

"I am confident this framework will strengthen INEC's reputation through a homegrown dashboard that enhances our capacity to assess regional risk profiles, deploy data-driven messaging, and establish early-warning systems against misinformation. Such strategic communication will boost public trust and deepen the credibility of future elections," he said.

Last month, NIPR, in partnership with Reputation Perception Services (RPS), unveiled the Nigeria Reputation Perception Index (NRPI) Report 2025, which highlighted gaps contributing to the nation's low RPI score of 35.2, showing how electoral cycles significantly influence national reputation.

The consultative forum drew media executives from over 160 institutions, all National INEC Commissioners, the

Secretary of the Commission, Mrs Rose Oriaran-Anthony, fnipr, Resident Electoral Commissioners, and other senior INEC officials.

During the meeting, Prof. Dandaura presented Prof. Amupitan with copies of the Nigeria Reputation Perception Index Report 2025 and the Strategic Electoral Intelligence Framework document.

C'River to Partner NIPR on Tax Education Drive

.. as IRS gets Corporate Membership from the Institute

The Cross River State Government has announced plans to partner with the Nigerian Institute of Public Relations (NIPR) to

educate taxpayers on their civic responsibilities, particularly in relation to the new tax reforms.

The initiative is

aimed at promoting voluntary tax compliance and deepening public awareness across the State.



The Executive Chairman of the Cross River State Internal Revenue Service (CRIRS), Prince Edwin Okon, disclosed this during an interactive session with the Cross

River State Chapter Executive and members of NIPR led by its Chairman, Pst. Augustine Mboso, Thursday, at the CRIRS Headquarters in Calabar.

According to Prince Okon, such collaborations are key to properly inform taxpayers about the new tax regime, reducing misinformation, and improving voluntary



compliance, noting that partnerships with professional bodies like NIPR will drive effective communication, public sensitization, and grassroots engagement.

He further added that the Service is also open to training opportunities that will strengthen

communication capacity, enhance stakeholder engagement, and support the effective dissemination of tax-related information to the public.

Earlier, Dr. Augustine Mboso, State Chairman of the Nigerian Institute of Public Relations (NIPR),

Cross River State Chapter, lauded the Executive Chairman's digitalization efforts which he noted has contributed immensely to the drastic surge in revenue generation for the State.

Dr. Mboso assured the State's tax Boss that, as a



professional training institution, the NIPR was ready to explore every possible avenue to ensure eligible taxpayers are fully educated on their civic obligations.

The Chapter Chairman also called on the Executive Chairman to extend this "sanitization" process to all revenue-generating agencies. This move according to him would ensure administrative uniformity and put

an end to the unwarranted harassment of taxpayers across the State by revenue collecting agents and assured him of their readiness to partner the service in the area of training.

Also speaking, the immediate past State Chairman of the Institute, Mr. Benedict Okache, thanked the Executive Chairman and IRS for being a consistent partner of the NIPR for over 20 years and appealed for the robust partnership to continue in the

years ahead.

On behalf of the National President of the Institute, Dr. Ike Neliaku, the Cross River State Chapter Chairman, Dr Augustine Mboso, later conferred Corporate Membership on the Service and charged the agency to live up to the expectations of its new status when engaging with the citizens of Cross River.





Global Fund Donate Five Sets of Portable Digital X-ray Machines to the C'River

An International Development Partner operating in the State, Global Fund through indigenous Nongovernmental Organizations KNCV has donated five sets of portable digital x-ray machines to the Cross River State Government.

Receiving the items on behalf of the State Government at the State Planning Commission building, New Secretariat Complex Calabar. The Commissioner, Ministry of International Donor Coordination, Dr Hippolatus Ogar Lukpata expressed delight with the

donation facilitated by KNCV to support the State efforts in the elimination of TB and related diseases.

According to the Commissioner, he feels fulfilled with the support the State has received to address TB prevalence, adding that there should



be sustainability plans through manpower training in the Management of the equipments and maintenance in case of breakdown.

He requested that a monitoring and

evaluation component be activated in the various Hospitals that will benefit the machines to enhance maintenance and sustainability to prolong the lifespan of the machines and appreciate the

management of KNCV Nigeria for their support to the State.

Earlier, the Senior Programme Officer, KNCV Project Cross River State Dr. Cynthia Onwuteaka said KNCV is an

Prof. Odey Interact with Education Stakeholders to Enforce Reforms

The Cross River State Commissioner for Education, Senator Professor Stephen Odey, has held the first stakeholders' meeting of the year with management and





critical partners in the education sector at the Ministry of Education headquarters in Calabar.

Welcoming stakeholders and management staff, the Commissioner described the meeting as a





strategic platform to assess progress and chart a clear course for the year. He noted that education remains one of the most critical sectors in the country and the state, stressing that "if education fails, every other sector will fail."

He emphasized that a lot is expected of the sector under the leadership of His Excellency, Senator Dr. Bassey Edet Otu, and called for collective responsibility in meeting those expectations.

Senator Odey expressed concern

over the slow pace of registration for Primary Six Placement, Basic Education Certificate Examination (BECE), and SS2 Mock Examinations, describing the trend as unacceptable. He warned school



heads against withholding pupils' and students' registration fees in a bid to extort additional charges, directing that such practices must stop immediately.

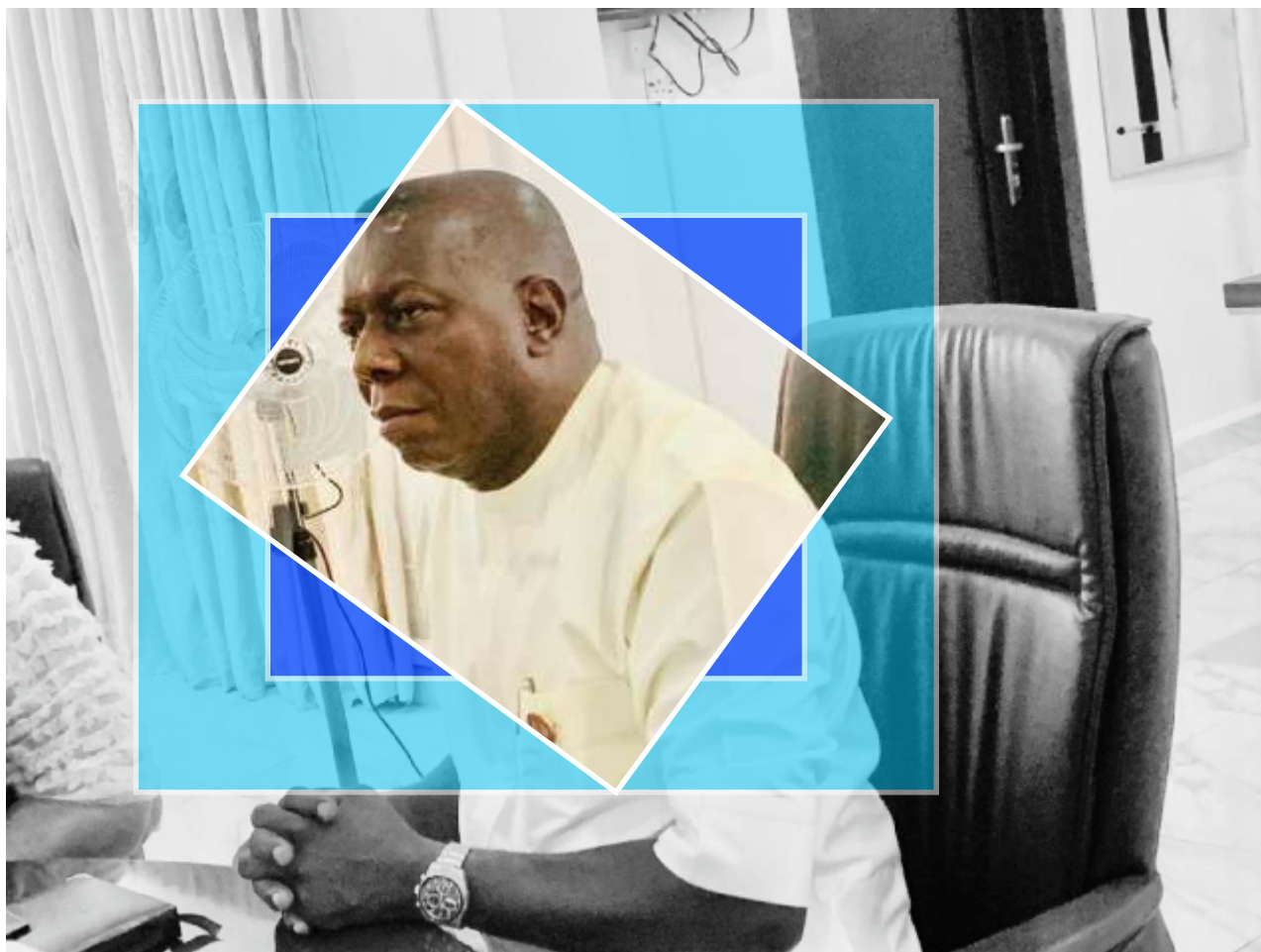
He further announced that henceforth, both public and private schools that

admit students into JSS1 without valid Primary Six Placement slips will be sanctioned, as part of efforts to strengthen transparency and curb malpractice in the system.

The Commissioner disclosed that the Ministry has completed the compilation of 13,289 indigenous

SS3 students for the 2026 state government-sponsored WAEC registration, noting that the list is awaiting the approval of the Governor.

He also informed stakeholders that the Federal Ministry of Education has directed that there will be no



transfer or admission into SS3 during the 2026/2027 academic session, urging school administrators to strictly comply.

On performance, Senator Odey revealed that 2025 analysis shows that 70.8% of students

recorded five credits and above, including Mathematics and English, expressing optimism that the state would record even better results in the coming year.

The Commissioner expressed displeasure over the failure of some Executive

Secretaries to submit accurate enrolment data for pupils and students, warning that any Executive Secretary who fails to comply will be queried. He urged all officers to step up and discharge their responsibilities

diligently.

Senator Odey called on all stakeholders to sustain and deepen the ongoing reforms in the education sector, noting that other states are already emulating Cross River State's education reforms, a clear indication that the state is on the right path.

During the meeting, the Commissioner formally introduced the new Head of Department, Quality Assurance, Dr. (Mrs.) Fanni, and presented her letter of appointment.

He also issued a stern warning against leakage of WAEC

examination question papers, stating that any local government, school, or individual found culpable would face the full weight of the law. According to him, examinations are meant to prepare students for a better future, not to teach them how to cheat.

A special presentation was also made on the newly introduced Student Index Number, explaining its operations and importance. The technical presenter, Mr. Victor, explained that the index number will be used to track students from primary school through secondary education, enhancing data integrity and

accountability.

Stakeholders at the meeting, including Comrade Olayi, Dr. Anthony Ngban (Chairman, Senior Secondary School Board), Pastor Abraham Osok, and Dr. (Mrs.) Afiong Ugbaja (Special Assistant to the Governor), commended the Commissioner for his unwavering commitment to repositioning the education sector and making it one of the best in the country.

NG-CARES Target Vulnerable and Less Privileged in our society

Cross River Deploys AI-Powered Digital X-Ray Machines to Strengthen TB Detection

Cross River State has recorded a major breakthrough in its fight against Tuberculosis (TB) with the deployment of five state-of-the-art, Artificial

Intelligence-enabled portable digital X-ray machines aimed at strengthening active case-finding, particularly in high-burden communities.

The milestone initiative was

formally unveiled by the Honourable Commissioner for Health, Dr. Henry Egbe Ayuk, PhD, alongside the Senior Program Officer for the KNCV TB-LON Project, Dr. Cynthia Onwuteaka,



marking a significant leap in the state's respiratory health response.

The intervention, facilitated by the Global Fund through the National Tuberculosis, Buruli Ulcer and Leprosy Control Programme (NTBLCP), is

designed to accelerate early detection and treatment of TB, thereby reducing transmission and mortality. The advanced equipment has been strategically stationed at five key public health facilities across the state, with trained radiographers already deployed to

ensure effective and efficient use of the technology.

Speaking during a technical briefing, Dr. Onwuteaka described the deployment as a game-changer in TB control, noting that the AI-powered machines enable pre-symptomatic diagnosis, a



departure from the traditional symptom-based screening approach.

"This machine does a form of pre-symptomatic diagnosis where the X-ray is now used for screening," she explained. "Once lesions of TB are detected, even

when the patient has no symptoms, we are able to identify and manage the case. It is a major step forward in active case-finding within the community."

In his remarks, Dr. Ayuk commended the Global Fund and KNCV for their sustained partnership with the state, stressing that

the deployment aligns with global efforts to eliminate TB and other major epidemics by 2030.

"Universal Health Coverage is fundamental. The world is fighting against all forms of diseases, and government alone cannot do this," the Commissioner stated. "We are



deeply grateful for this support, and we will ensure that the personnel trained for this purpose are utilized maximally for the benefit of our people.”

He further assured that the Ministry of Health would provide the necessary leadership to guarantee proper utilization and maintenance of the equipment, adding that a comprehensive

briefing would be presented to the State Governor to highlight the technological advancement and its public health impact.

The engagement concluded with a firm commitment to fully integrate the AI-enabled digital X-ray technology into the state’s public health framework as part of broader efforts to strengthen disease surveillance, early diagnosis, and

effective response.

Also present at the meeting were the State Program Officer for the KNCV Global Fund GC7 Project, Dr. Enoch Asuquo; the State TBLCP Program Manager, Elder (Mrs.) Ajom Ikongha; and senior directors of the Ministry of Health, underscoring the collective resolve to scale up TB control efforts across Cross River State.

SEMA Partners with NDLEA to Combat Drug Abuse and Enhance Disaster Mgt.

In a strategic move to integrate paramilitary support into disaster management and curb the rising prevalence of drug abuse among youths, the Cross River State

Emergency Management Agency (SEMA) has announced a formal partnership with the National Drug Law Enforcement Agency (NDLEA).

The Director-General of SEMA, Mr. Antigha Edem

Gill, disclosed these plans on Wednesday during a courtesy visit from the NDLEA State Commandant, Mr. C.N. Anteyi John, and his team at the SEMA headquarters in Calabar.



While commending the NDLEA for its proactive stance against narcotics, he also briefed the visiting team on SEMA's ongoing efforts to decentralize emergency response,

specifically the inauguration of Local Emergency Management Committees (LEMC) across all 18 Local Government Areas of Cross River State.

To solidify this synergy, Gill extended an

invitation to the NDLEA to participate in the upcoming training sessions for LEMC personnel.

According to Mr Gill, this collaboration aims to create a unified front for handling



emergencies that often intersect with drug-related issues.

Earlier in the meeting, Commandant C.N. Anteyi John emphasized that

both agencies are ultimately in the business of preserving human life.

He noted that the visit was an exploratory step toward keeping the

State safe from illicit substances and managing the fallout of drug-induced disasters and promised the work with SEMA.

The visit concluded with a mutual



pledge to deepen the working relationship between the two organizations.

Experts believe

that by combining SEMA's logistical reach with the NDLEA's enforcement expertise, the state aims to create a

more resilient and drug-free environment for its citizens.

Ayuk Champions Proactive Scholarship Model to Boost School Enrollment in Etung

No fewer than 291 JSS 1 students in public secondary schools across Etung Local Government Area have benefitted from a proactive scholarship charity model initiated by

the Honourable Commissioner for Health, Dr. Henry Egbe Ayuk, in a strategic push to eliminate financial obstacles to education.

The initiative took a significant step

forward on Tuesday during a high-level engagement between Dr. Ayuk and the Teacher Okongor Asu Ayuk Education Foundation team at the Ministry of Health



headquarters in Calabar. The meeting focused on the successful disbursement of the first tranche of scholarship support for 291 JSS 1 students across public schools in Etung, the formal presentation of the 2025/2026 scholarship template, and the

adoption of an innovative "Enrollment-First" strategy designed to drive early and sustained school attendance across the LGA's ten political wards.

Commending the Foundation's committee for developing a transparent and technically sound

roadmap, Dr. Ayuk explained that the initiative, established in honour of his late father, is deliberately structured as a sustainable best-practice model capable of attracting future stakeholders and development partners.

"I deeply appreciate the effort put into this, especially the successful payment for the first term of the 2025/2026 academic session," Dr. Ayuk said. "We are building a system where any partner can come in and clearly see where their support is going. We will ensure that the structures created are utilized maximally for the benefit of Etung children."

In his welcome address, the Chairman of the Foundation's Committee, Hon. Inok Kuti Ebak, PhD, reaffirmed education as the cornerstone of genuine societal development, noting that the committee remains committed to

ensuring that school fees are settled at the beginning of each term to encourage enrollment in public secondary schools.

"Whatever concerns education, I am passionate about it," he stated. "It is the bedrock for true growth and development. What we are doing may seem modest today, but the long-term impact on these students and the community will be immeasurable."

Providing further insight, the Committee Secretary, Hon. Prince Asu Ebam, outlined the 2025/2026 budget framework, which, he said, guarantees equitable coverage of beneficiaries across all ten political wards of Etung. He noted

that funds are being proactively directed to high-priority public community secondary schools, including Government Science School, Ekimkae, and Community Secondary School, Abijang, among others, to ensure that financial hardship does not disrupt attendance or learning.

The meeting concluded with a collective commitment to integrate modern data tracking systems and robust stakeholder engagement mechanisms into the Foundation's operations, further strengthening transparency, accountability, and scalability.

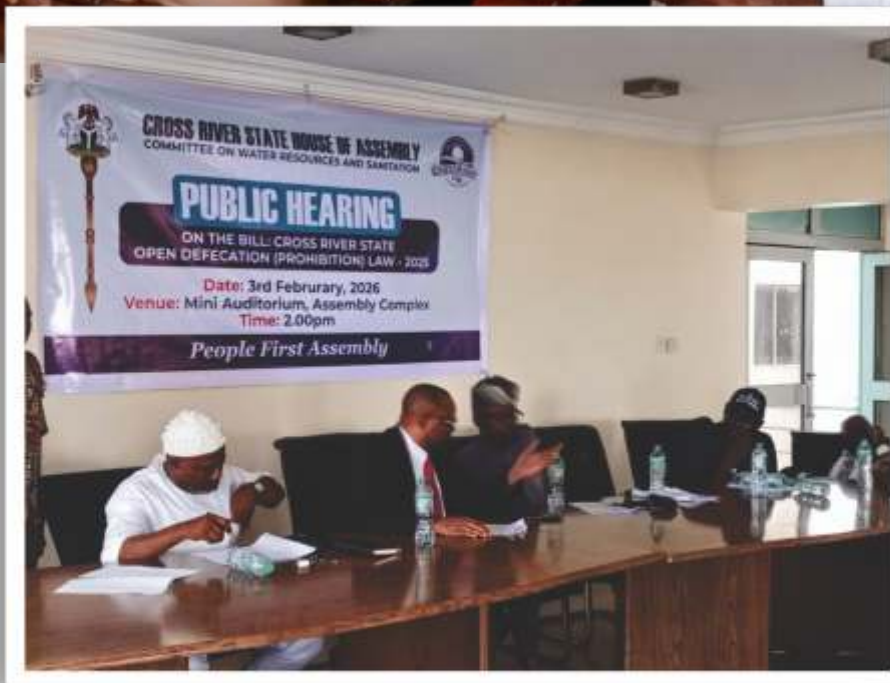

The World Broadcasting Day celebration, scheduled for February 12 and 13, will feature a symposium on February 12 and

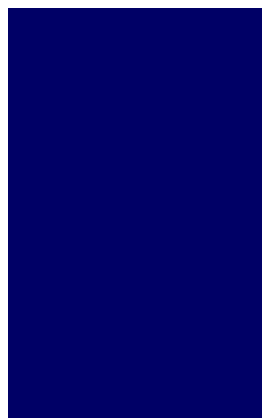
an award night on February 13 at the Metropolitan Hotel.

River State Local Government Law, the House unanimously resolved that Hon. Yakubu be suspended pending the outcome of an investigation by its Committee on Judiciary, Public Service Matters, Public Petitions and Conflict Resolution.

The motion for the suspension was moved by the Leader of the House, Rt. Hon. Francis Bassey Asuquo (Odukpani), and seconded by the Deputy Leader, Rt. Hon. Davies Etta (Abi).

In their separate

contributions, lawmakers stressed the need for strict adherence to the provisions of the Cross River State Local Government Law by councils, emphasizing that due process and accountability must be upheld at all levels of governance.

The impeachment notice, unanimously agreed upon by the ten councillors of the Ogoja Legislative Council, was read on the floor of the House by the Clerk of the Assembly, Barr. Catherine Ubi, during plenary. The notice cited



allegations of abandonment of duty for private business, breach of the Oath of Secrecy, disregard for constituted authority, among other infractions, which were said to have affected the smooth running and development of Ogoja Local

Government Council.

In a remark, the Speaker of the Cross River State House of Assembly, Rt. Hon. Elvert Ayambem, said the House would not tolerate actions capable of undermining effective local government

administration, adding that the Assembly remains committed to upholding due process and ensuring that elected officials discharge their responsibilities in accordance with the law and the expectations of the people.

Cross River State Government had on 28th July, 2025 issued a Press Statement titled "RE:76 OIL WELLS, RESTATEMENT OF FACTS" where all the emerging facts regarding the surreptitious allocation of Cross River State 76 Oil Wells to Akwa Ibom State and all related matters thereto were clearly enunciated for public information.

In 2025 Cross River State petitioned the President and RMAFC, NBC, NUPRC and OSGOF with evidence of 245 new Oil Wells derivation allocation with a comprehensive scientific, geological and Legal EVIDENCE justifying Cross River State's Oil producing Status.

An Inter-Agency Committee was constituted by Mr. President and exercise conducted in November 2025 confirming additional Oil Wells derivation allocation for Cross River. The current Inter-Agency Committee opened a public hearing for the presentation of the report having shared the coordinates to both States.

The result is obvious, Cross River State is an Oil producing State with Oil Wells within its maritime territory beyond, 67 or 76 Oil Wells.

As at today, Cross River still maintains that position which necessitated the writing of the petition in the first Instance to the President, His Excellency, Asiwaju Bola Ahmed Tinubu, GCFR, over the injustice meted to us as a State.

We bore the brunt of handing over a part of Bakassi to the Republic of Cameroon all these years. It baffles our imagination how only a portion of Bakassi was ceded to Cameroon while the Oil Wells found their way to Akwa Ibom that was not part of the dispute in the first place.

Thanks to Mr. President, the Federal Government Inter-Agency Technical Committee was set up to look into the emerging matters.

Comprehensive visits, mappings and findings have been made to the area in dispute by all concerned and new discoveries have emerged in the area which was not demarcated, boundaries have been set between the Cross River State estuaries and the Cameroon.

Therefore, the Committee should be allowed to present their findings to show the actual location of the Oil wells within both States. Cross River State deplores every divisive plot to disrupt the conclusion of this findings, report and implementation.

We have absolute confidence in the joint Committee and urge them to remain resolute in rewriting the wrongs of the past.

Cross River State under the Administration of Sen. Prince Bassey Otu is governed by God. What is truly ours will be returned to us.

We are hopeful of getting back all our Oil Wells.
